PART OF AUDITORS PARCEL  
17-30-02-05-000 (4.352 Acres)

Situated in the Quarter Township 2, T-1-N, R-3-E, N-1-L., Falls Township, Muskingum County, Ohio. Being part of the lands of Lois Marie Worthington conveyed in Deed Book 1047 Page 31 of the Muskingum County Plat records and being described as follows:

Commencing at the Southwest corner of Quarter Township 2; Thence, N.00°00'00"E. a record distance of 4960.00 feet along the West line of said quarter township to a point in the centerline of Twin Hills Drive; Thence, S.85°42'00"E. a record distance of 59.00 feet along the centerline of said road; Thence, N.42°46'00"E. a record distance of 278.00 feet along the centerline of said road; Thence, N.52°24'00"E. a record distance of 422.00 feet along the centerline of said road; Thence, S.75°42'00"E. a record distance of 321.50 feet along the centerline of said road; Thence, S.77°03'34"E. a distance of 253.69 feet along the centerline of said road to a point on the Northeast corner of the lands, now or formerly, owned by M. Krause (622/13), BEING THE POINT OF BEGINNING;

Thence, S.77°02'32"E. a distance of 311.34 feet along the centerline of Twin Hills Drive to a point;

Thence, on a curve to the left, an arc distance of 228.58 feet, on a radius of 654.85 feet, whose chord bears S.87°03'00"E. a distance of 227.42 feet along the centerline of Twin Hills Drive to a point;

Thence, N.82°57'00"E. a distance of 34.11 feet along the centerline of Twin Hills Drive to a point, on the Northwest corner of the lands, now or formerly, owned by W. Weiser, II (1681/228);

Thence, S.07°03'00"E. a distance of 300.31 feet along the West line of said Weiser lands to a found rebar on the Northline of the lands, now or formerly, owned by The Weiser Family Trust (1571/839), passing a found rebar at 19.76 feet;

Thence, S.82°56'35"W. a distance of 201.53 feet along said Trust lands to a found iron pipe;

Thence, N.77°02'45"W. a distance of 480.53 feet along said Trust lands to a found iron pipe on the Southeast corner of the afore said lands of M. Krause;

Thence, N.12°55'07"E. a distance of 300.00 feet along the East line of said Krause lands to the point of beginning, passing a found iron pipe at 279.86 feet.

The above described parcel contains 4.352 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. # SURVEY PLAT FOR LOIS MARIE WORTHINGTON

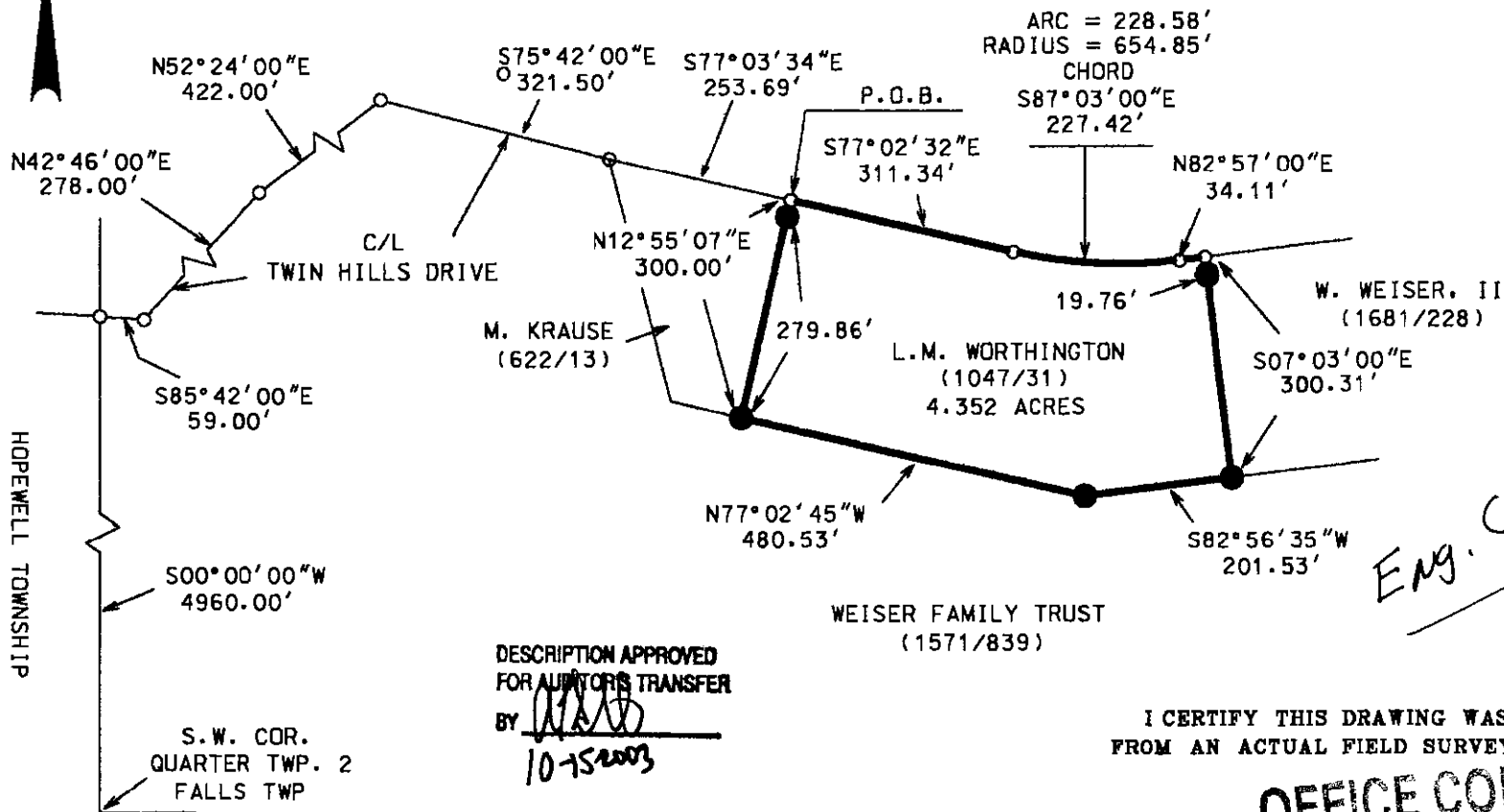
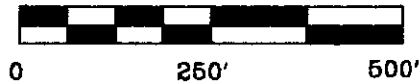
SITUATED IN QUARTER TOWNSHIP 2, T-1-N, R-8-W, U.S.M.L, FALLS TOWNSHIP,
