

Survey for Alan H. and Carol S. Wilson

Being in the State of Ohio, Muskingum County, Falls Township, Quarter Township, Township 1 North, Range 8 West, and part of Lot 37 of Military Gardens (Plat Book 7, page 49), and being part of the lands conveyed to Alan H. Wilson and Carol S. Wilson in Official Record 1888, page 284 in the Muskingum County Records Office, and bounded and described as follows:

Commencing at an iron pin found at the northeast corner of Lot 37 of Military Gardens (Plat Book 7, Page 49);
thence along the east line of Lot 37 South 04 degrees 30 minutes 00 seconds West 116.30 feet to an iron pin set;
thence continuing along the east line of Lot 37 South 04 degrees 30 minutes 00 seconds West 109.00 feet to an iron pin set, the principal **place of beginning** for this parcel;

thence continuing along the east line of Lot 37 South 04 degrees 30 minutes 00 seconds West 926.70 feet to an iron pin set, being the southeast corner of Lot 37;

thence along the south line of Lot 37 North 87 degrees 53 minutes 11 seconds West 362.00 feet to an iron pin set on the east line of Olde Falls Road (CR 298) (40' wide);

thence along the east line of Olde Falls Road (CR 298) (40' wide) North 05 degrees 31 minutes 10 seconds East 16.71 feet to an iron pin set;

thence continuing along the east line of Olde Falls Road (CR 298) (40' wide) North 01 degrees 25 minutes 00 seconds West 691.00 feet to a point, an iron pin set being South 83 degrees 55 minutes 25 seconds East 9.12 feet;

thence continuing along the east line of Olde Falls Road (CR 298) (40' wide) North 10 degrees 15 minutes 00 seconds East 242.35 feet to a point;

thence leaving the east line of Olde Falls Road (CR 298) (40' wide) South 85 degrees 01 minutes 30 seconds East 20.00 feet to an iron pin set;

thence continuing South 85 degrees 01 minutes 30 seconds East 388.35 feet to the principal place of beginning, containing 8.65 acres, more or less.




