

DESCRIPTION OF SURVEY FOR DAVID BENTLEY

Situated in the State of Ohio, County of Muskingum, Township of Falls:

Being part of Lot #37 of Military Gardens a subdivision of Quarter Township #1, Township #1, Range #8, of the US Military District, **being part of** the Alan and Carol Wilson property recorded in Official Record Volume 1888, Page 284 of said county's deed records, further known as Muskingum County **Auditor's Parcel Number 17-33-02-01-000**, and more particularly described as follows;

Commencing at an iron pin (found) at the Northeast corner of said Lot #37 and Military Gardens, also being a common corner for the F Thomas Kearns Family Ltd. Partnership property recorded in Official Record Volume 1520, Page 316; **THENCE South 01 degrees 27 minutes 50 seconds West 534.80 feet** along the common line for said Lot #37, Military Gardens, and Kearns property to the unmarked place of beginning for the property herein intended to be described;

- #1- **THENCE South 01 degrees 27 minutes 50 seconds West 143.00 feet** continuing along the common line for said Lot #37, Military Gardens, and Kearns property to an iron pin (set);
- #2- **THENCE North 79 degrees 54 minutes 05 seconds West 234.97 feet** into said Lot #37 to an iron pin (set);
- #3- **THENCE South 45 degrees 36 minutes 35 seconds West 104.49 feet** continuing through said Lot #37 to an iron pin (set);
- #4- **THENCE South 85 degrees 09 minutes 20 seconds West 100.64 feet** continuing through said Lot #37 to an unmarked point on the West line of said Lot #37 and on the East line of Old Falls Road (County Road #298), passing an iron pin (set) at 59.32 feet;
- #5- **THENCE North 04 degrees 27 minutes 10 seconds West 198.86 feet** along the common line for said Lot and Road to an unmarked point;
- #6- **THENCE South 87 degrees 59 minutes 30 seconds East 425.63 feet** crossing said Lot #37 to the place of beginning, passing an iron pins (set) at 25.91 feet, and 419.20 feet, **containing 1.41 acres.**
