BEGINNING AT AN AXLE FOUND AT THE SOUTHEAST CORNER OF LOT #10 OF SAID SUBDIVISION, SAID POINT ALSO BEING ON THE WESTERLY LINE OF EAST HIGHLAND DRIVE, THENCE, SOUTH 81 DEGREES - 33 MINUTES - 00 SECONDS WEST, 140.16 FEET, ALONG THE SOUTH LINE OF SAID LOT, TO AN IRON PIN FOUND AT THE SOUTHWESTERLY CORNER THEREOF;

THENCE, SOUTH 53 DEGREES - 12 MINUTES - 52 SECONDS WEST, 50.00 FEET TO AN IRON PIN FOUND IN LOT #12;

THENCE, NORTH 19 DEGREES - 28 MINUTES - 20 SECONDS WEST, 60.57 FEET TO AN IRON PIN FOUND ON THE NORTHWESTERLY LINE OF SAID LOT #12;

THENCE, NORTH 41 DEGREES - 42 MINUTES - 56 SECONDS EAST, 50.35 FEET TO A POINT AT THE MOST NORTHERLY CORNER OF LOT #12, SAID POINT ALSO BEING THE MOST WESTERLY CORNER OF LOT #9, FROM WHICH POINT, AN IRON PIN FOUND, BEARS SOUTH 05 DEGREES - 02 MINUTES - 13 SECONDS EAST, 0.47 FEET;

THENCE, ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 97.00 FEET, A LENGTH OF 18.00 FEET, THE CHORD OF WHICH BEARS NORTH 48 DEGREES - 07 MINUTES - 21 SECONDS WEST, 17.97 FEET TO A POINT, FROM WHICH AN IRON PIN FOUND BEARS NORTH 53 DEGREES - 30 MINUTES - 20 SECONDS WEST, 0.23 FEET;

THENCE, NORTH 32 DEGREES - 52 MINUTES - 14 SECONDS EAST, 140.12 FEET TO AN IRON PIN FOUND ON THE SOUTHWESTERLY LINE OF EAST HIGHLAND DRIVE;

THENCE, ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 237.00 FEET, A LENGTH OF 195.15 FEET, AND A DELTA OF 47 DEGREES - 10 MINUTES - 42 SECONDS, THE CHORD OF WHICH BEARS SOUTH 32 DEGREES - 01 MINUTES - 50 SECONDS EAST, 189.68 FEET TO A POINT;

THENCE, SOUTH 09 DEGREES - 07 MINUTES - 51 SECONDS EAST, 13.20 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.5545 ACRES MORE OR LESS.

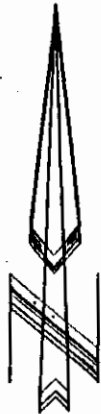
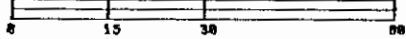
