thence by prior deed the following eight courses:

- 2) South 83 degrees 53 minutes 35 seconds East 217.98 feet to a point;
- 3) South 02 degrees 28 minutes 55 seconds West 647.64 feet to a point;
- 4) South 83 degrees 21 minutes 40 seconds East 100.00 feet to a point;
- 5) South 01 degrees 05 minutes 35 seconds West 222.17 feet to a point;
- 6) South 83 degrees 19 minutes 35 seconds East 357.98 feet to a point;
- 7) North 19 degrees 34 minutes 30 seconds East 162.96 feet to a point;
- 8) South 70 degrees 34 minutes 50 seconds East 50.00 feet to an iron pin found on the southwest corner of lands now owned by Russell L. Dingley (DR 1158-665) and the principal place of beginning;

thence along Dingey's south line South 70 degrees 32 minutes 07 seconds East 203.29 feet to an iron pin found on the west line of lands now owned by Charles H., Jr. and Gaynelle Archer (DR 685-336);

thence along Archer's west line and the east line of an existing 20 foot ingress/egress easement South 19 degrees 36 minutes 38 seconds West 179.41 feet to an iron pin set;

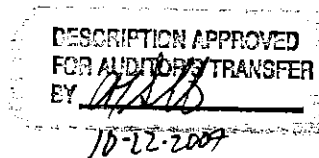

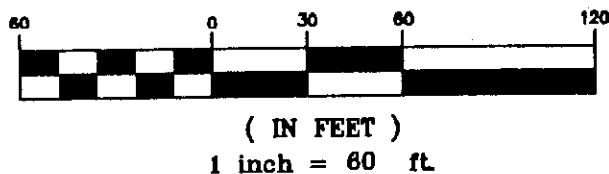
