COMMENCING AT THE NORTHEAST CORNER OF LOT NUMBER 18; THENCE SOUTH 02 DEGREES 06 MINUTES 35 SECONDS WEST 1734.94 FEET (BY DEED) TO A POINT ON THE EAST LINE OF LOT NUMBER 13; THENCE SOUTH 83 DEGREES 53 MINUTES 35 SECONDS EAST 217.98 FEET (BY DEED) TO A POINT; THENCE SOUTH 02 DEGREES 28 MINUTES 55 SECONDS WEST 647.64 FEET (BY DEED) TO A POINT; THENCE SOUTH 83 DEGREES 21 MINUTES 40 SECONDS EAST 100.00 FEET (BY DEED) TO A POINT; THENCE SOUTH 01 DEGREES 05 MINUTES 35 SECONDS WEST 222.17 FEET (BY DEED) TO A POINT; THENCE SOUTH 83 DEGREES 19 MINUTES 35 SECONDS EAST 357.98 FEET (BY DEED) TO A POINT AT THE NORTHEAST CORNER OF A TRACT CONVEYED TO S. A. 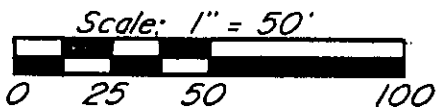

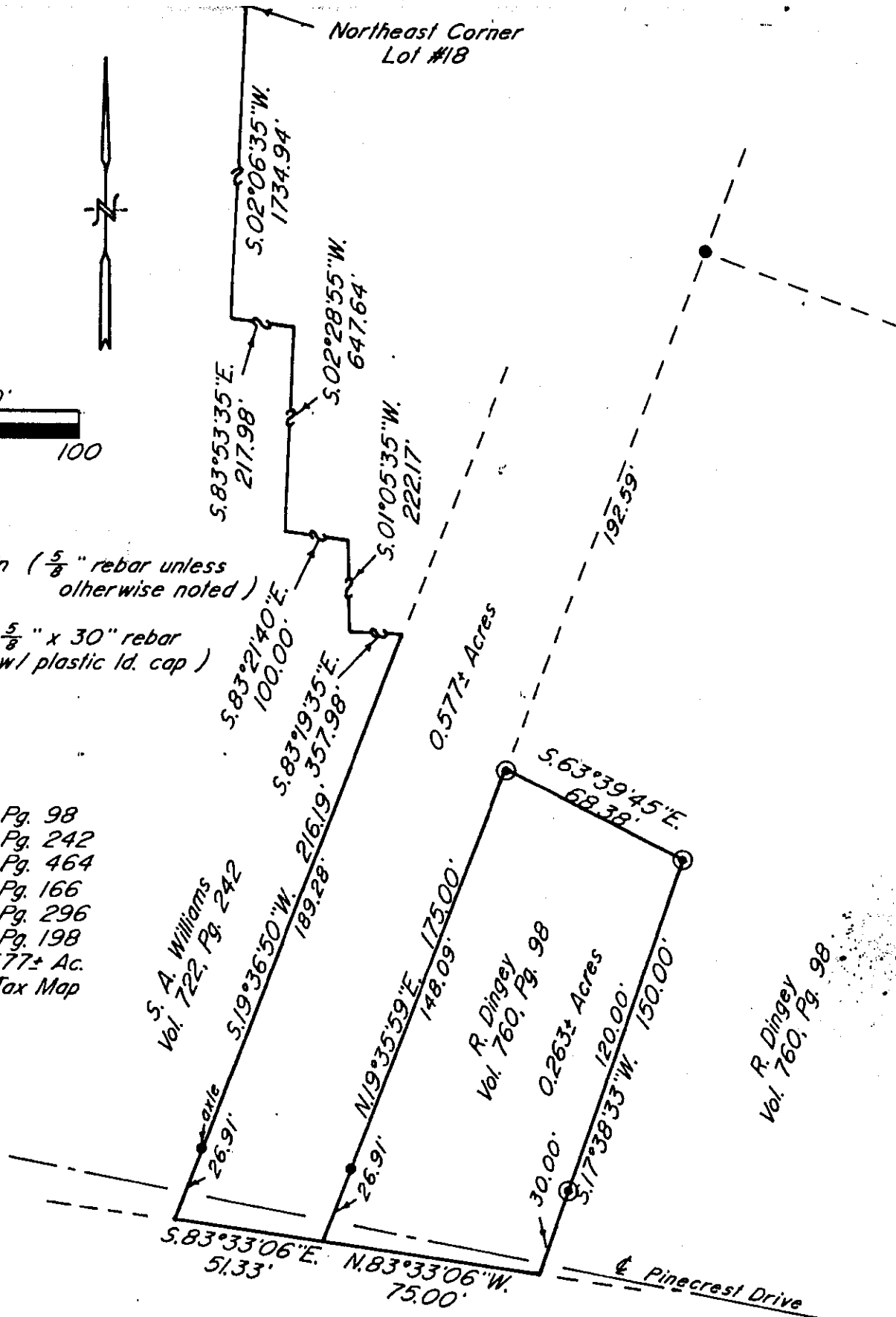
Northeast Corner
