LEGAL DESCRIPTION FOR HAROLD TEISINGER PROPERTY

Situated in the State of Ohio, County of Muskingum, Township of Falls, and being part of Quarter Township 3, Township 1, Range 8, and being all those lands intended to be described in Deed Volume 1521, page 73; being further bounded and described as follows:

Commencing at the northwest corner of Lot #8 of Wildwood Subdivision, as recorded in Plat Book 8, page 89, thence, south 65 degrees – 45 minutes – 17 seconds west, 60.00 feet to a point; thence, north 36 degrees – 01 minutes – 00 seconds west, 2075.25 feet to a point; thence, north 52 degrees – 00 minutes – 00 seconds east, 427.99 feet to a point; thence, north 33 degrees – 16 minutes – 50 seconds west, 620.67 feet to an iron pin found, and the *true point of beginning* for the parcel herein intended to be described;

Thence, south 30 degrees – 37 minutes – 46 seconds west, 236.34 feet to an axle found;

Thence, north 33 degrees – 13 minutes – 14 seconds west, 441.44 feet to a point in the center of Dillon Falls Road, passing an iron pin found at 419.23 feet;

Thence, north 30 degrees – 29 minutes – 42 seconds east, 111.29 feet to a point in said road;

Thence, continuing along Dillon Falls Road, north 56 degrees – 10 minutes – 43 seconds east, 112.37 feet to a point;

Thence, leaving Dillon Falls Road, south 33 degrees – 13 minutes – 14 seconds east, 387.74 feet to the *point of beginning*, passing an iron pin found at 20.00 feet, and containing 2.081 acres more or less.

Bearings described herein are based upon assumed azimuth and to be used for angle purposes only.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Being all of Auditor's Parcel #17-52-03-45-000.

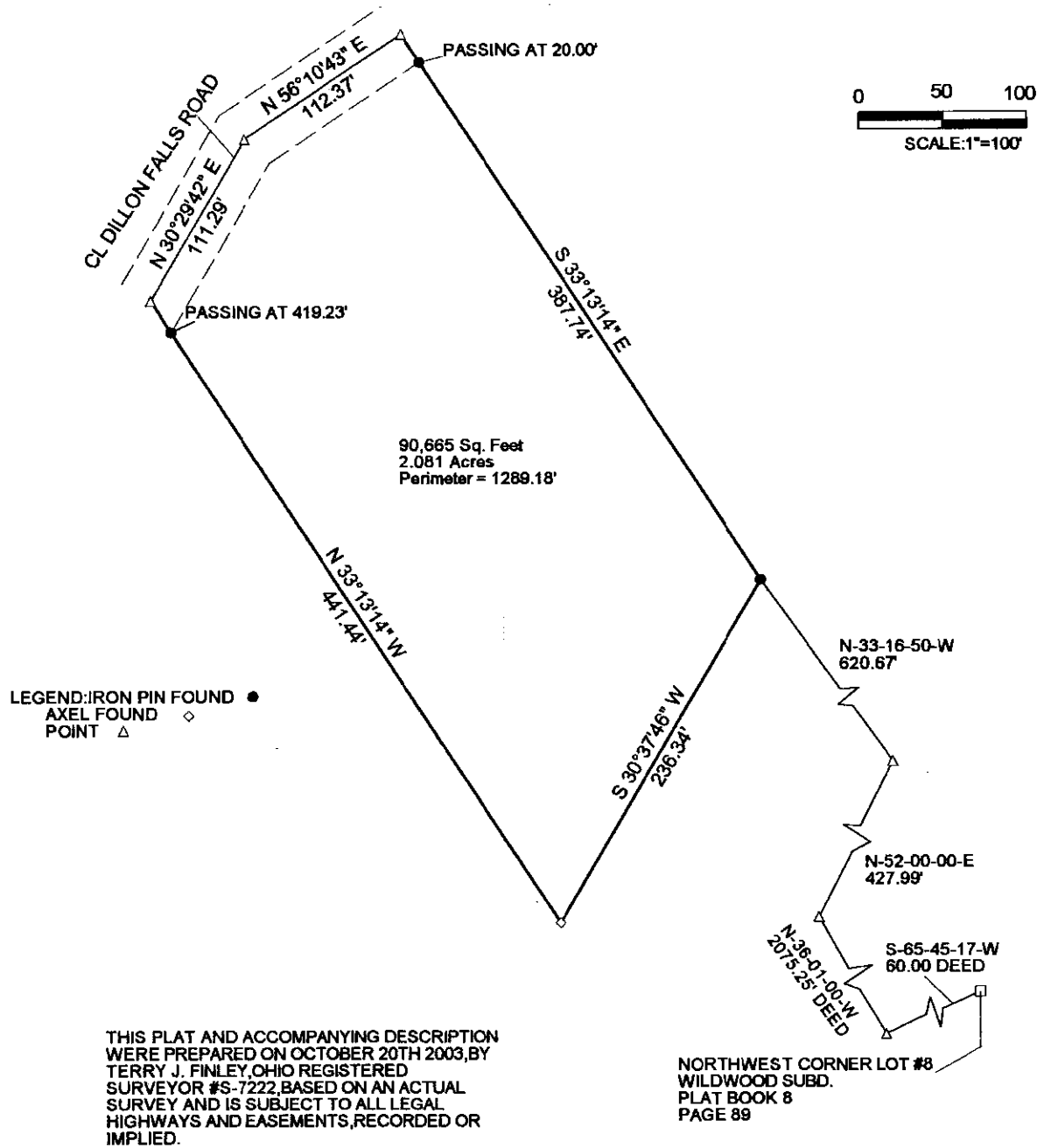

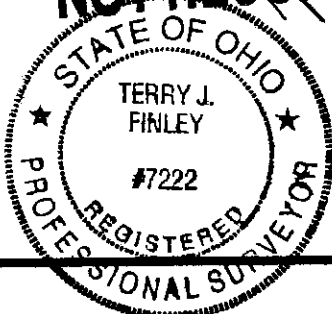
