Beginning for a point of reference at an iron pin found at the South-
easterly corner of Lot 28 of Maryland Heights Part #2 as shown on the
plat recorded in Plat Book 10, Page 34 of the Muskingum County Plat
Records, said point being on the Westerly line of Spring Street; thence
South 26° 46' 00" East 249.89 feet along the Westerly line of Spring
Street extended to an iron pin set, said point being the true place
of beginning of this tract, passing an iron pin found at the South-
easterly corner of a 0.96 acre tract surveyed by L. Peter Dinan (Reg.
Surveyor #5451) and shown on a plat dated Aug. 6, 1971 at 199.89 feet
thence continuing South 26° 46' 00" East 125.00 feet along Spring
Street extended to an iron pin set; thence South 63° 14' 00" West
209.83 feet to an iron pin set; thence North 26° 46' 00" West 125.00
feet to an iron pin set, said point being South 26° 46' 00" East 50.00
feet from the Southwesterly corner of the aforementioned 0.96 acre
tract; thence North 63° 14' 00" East 209.83 feet to the place of be-
ginning.

Containing 0.6021 acres, subject to any valid and existing easements
of record.

The bearings used in this description are based on the South line of
Lot 28 having a bearing of South 63° 14' 00" West as shown on the plat
of Maryland Heights Part 2. The iron pins described as set are 5/8
inch diameter, 30 inches long, solid reinforcing bars with plastic
identification caps.


