Beginning at an axle found at the northeast corner of Lot 1 of Ridgewood Annex Addition to the City of Zanesville, Ohio as designated and delineated on Muskingum County Plat Book 6, Page 20; thence along the north line of said lot North 86 degrees 43 minutes 43 seconds West 325.02 feet to an axle found on the northwest corner of lands now owned by A. and F. Lamonica (Deed Record 446, Page 237); thence North 02 degrees 33 minutes 28 seconds East 234.98 feet to an axle found on the northeast corner of lands now owned by P. Haynes (Deed Record 450, Page 85); thence along the south line of lands now owned by M. and K. Watson (Deed Record 1034, Page 13) South 86 degrees 03 minutes 00 seconds East 372.92 feet to a point on the centerline of County Road 2 (Dresden Road); passing an axle found at 342.92 feet; thence along said centerline South 06 degrees 58 minutes 44 seconds West 231.03 feet to a point; thence North 86 degrees 43 minutes 43 seconds West 30.00 feet to the place of beginning, containing 1.95 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.
