Being a part of the north half of quarter township 3, township 1, range 7,
bounded and described as follows:

Beginning at the northeast corner of lot 6 in Treehouse Lane Addition and recorded in plat book 14, pages 92 and 93 of the plat records of said county; thence north 40 degrees 36 minutes 25 seconds west along the northerly line of said lot 6, a distance of 32.44 feet to an iron pin; thence north 55 degrees 03 minutes 45 seconds west along said northerly line a distance of 80.26 feet to an iron pin; thence north 72 degrees 19 minutes 45 seconds west along said lot line a distance of 65.00 feet to an iron pin; thence north 29 degrees 40 minutes 48 seconds east along the easterly line of parcel 3 a distance of 153.39 feet to an iron pin; thence on a curve to the left having a radius of 50.00 feet the chord of which bears north 71 degrees 37 minutes 07 seconds east a chord distance of 74.38 feet an arc distance of 83.88 feet to an iron pin; thence north 83 degrees 33 minutes 27 seconds east along the southerly line of Creek Side Circle a distance of 49.12 feet to an iron pin; thence south 19 degrees 26 minutes 33 seconds east along the westerly line of parcel 5 a distance of 78.00 feet to an iron pin; thence south 12 degrees 18 minutes 02 seconds west along said westerly line a distance of 32.46 feet to an iron pin; thence south 06 degrees 44 minutes 31 seconds west along said westerly line a distance of 198.00 feet to an iron pin; thence north 40 degrees 36 minutes 25 seconds west along the northerly line of lot 5 in said addition a distance of 65.00 feet to the place of beginning, containing Eighty Two (0.82) hundredths of an acres more or less.

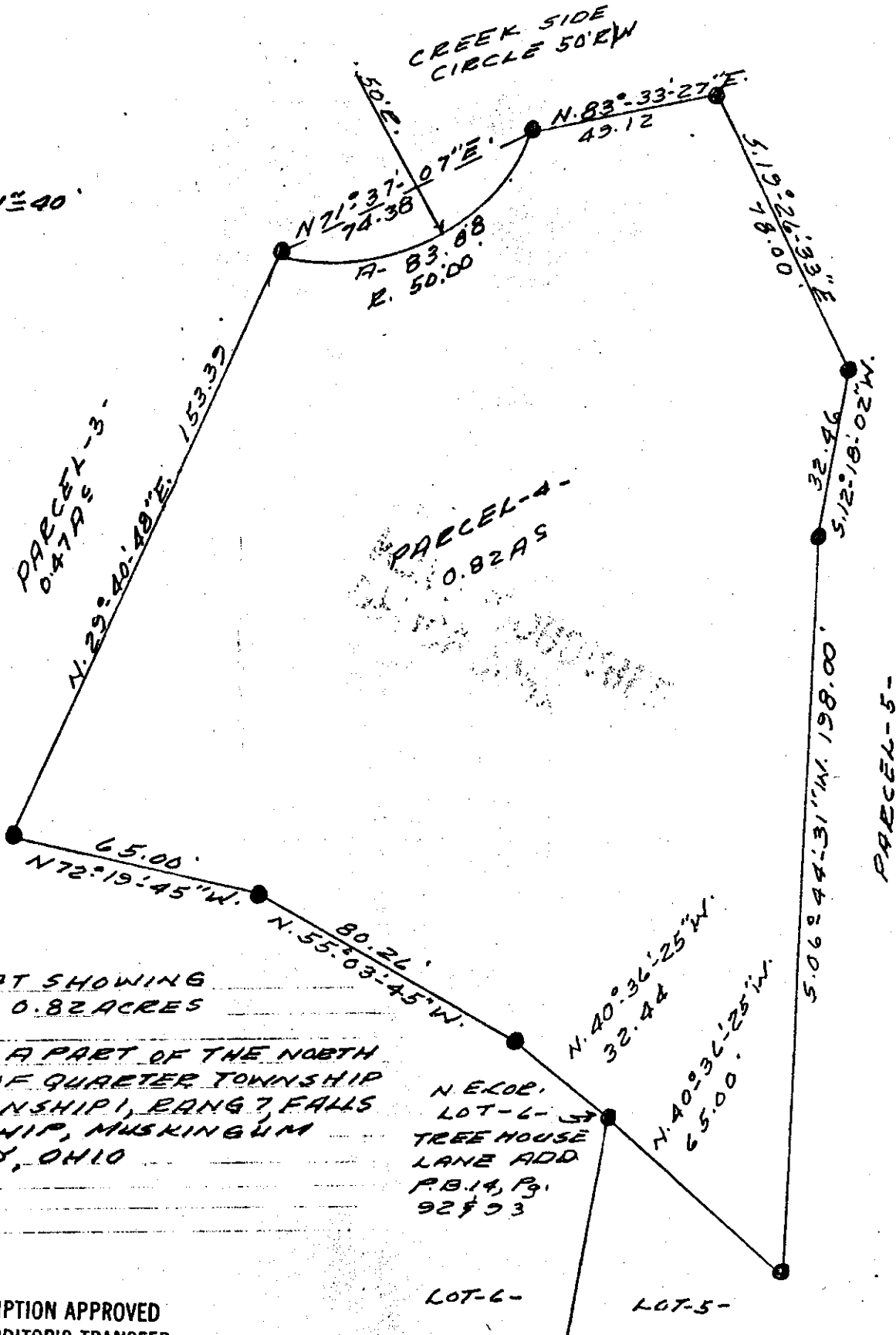
