COMMENCING AT THE SOUTHWEST CORNER OF FIVE OAKS SUBDIVISION, AS RECORDED IN PLAT BOOK 4, PAGE 84, AT THE CENTERLINE OF STATE ROUTE 146; THENCE, NORTH 54 DEGREES - 02 MINUTES - 00 SECONDS WEST, 696.40 FEET TO A POINT; THENCE, NORTH 61 DEGREES - 17 MINUTES - 00 SECONDS WEST, 492.85 FEET TO A POINT; THENCE, NORTH 33 DEGREES - 00 MINUTES - 00 SECONDS WEST, 400.00 FEET TO A POINT IN SAID ROAD; THENCE, SOUTH 67 DEGREES - 00 MINUTES - 00 SECONDS WEST, 38.00 FEET TO AN IRON PIN SET AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING SOUTH 67 DEGREES - 00 MINUTES - 00 SECONDS WEST, 198.00 FEET TO AN IRON PIN SET, PASSING RIGHT-OF-WAY MONUMENTS FOUND AT 65.41 FEET AND 75.66 FEET; THENCE, NORTH 37 DEGREES - 39 MINUTES - 27 SECONDS WEST, 103.30 FEET TO AN IRON PIN SET; THENCE, NORTH 67 DEGREES - 00 MINUTES - 00 SECONDS EAST, 209.50 FEET TO AN IRON PIN SET; THENCE, SOUTH 31 DEGREES - 20 MINUTES - 00 SECONDS EAST, 101.00 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.467 ACRES MORE OR LESS.

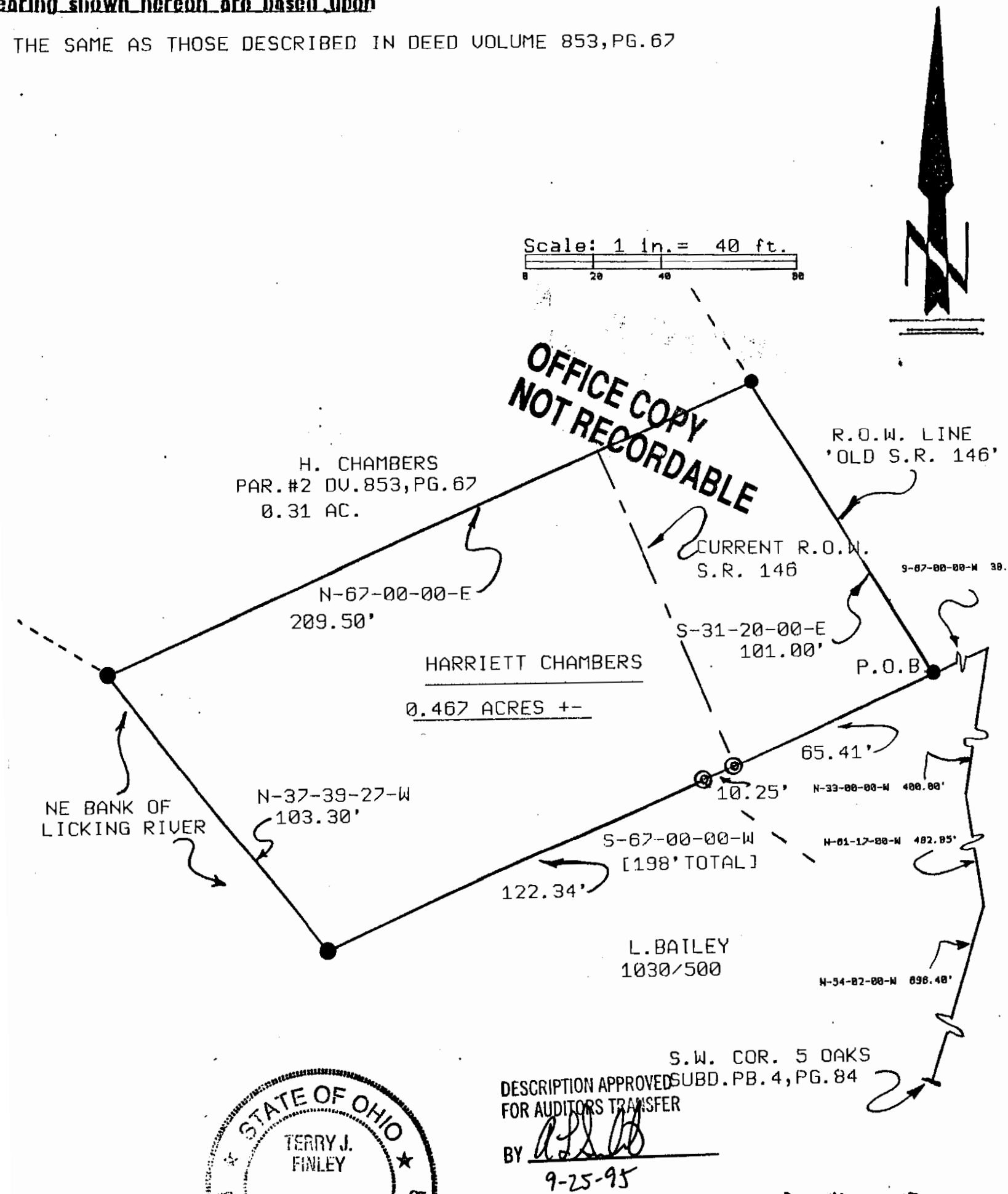
