

Situated in the 4th Quarter of Township 1 North, Range 8 West of the United States Military Lands, Falls Township, Muskingum County, Ohio [and being all of the property conveyed to Rose McPherson by deeds recorded in Deed Book 1121, page 547; Deed Book 1136, page 117 and Deed Book 2058, page 891 (Aud. Par. #17-73-02-19-000, all and Aud. Par. #17-73-02-20-000, all) and being further bounded and described as follows:

Beginning at a stone found at the Northwest corner of "The Maples Subdivision" as shown on the plat recorded in Plat Book 5, page 9;

thence South 86° 53' 55" East, along the South line of a tract conveyed to The President and Board of Trustees of Ohio University by a deed recorded in Deed Book 538, page 799, a distance of 2.00 feet to an iron pin set;

thence South 03° 02' 21" West, along the East line of a 2.00 foot reserved strip as shown on the plat of the aforementioned Maples Subdivision, a distance of 743.94 feet to an iron pin set;

thence North 72° 57' 53" West, along the North line of a tract conveyed to Tammy L. McKinney by a deed recorded in Deed Book 2039, page 902, a distance of 43.58 feet to an iron pin set;

thence South 20° 55' 56" West, along the West line of said McKinney tract and passing a ½ inch pipe found at a distance of 253.96 feet, a total distance of 279.00 feet to a point in the center of State Route 146 (Newark Road);

thence North 66° 54' 23" West, along the centerline of State Route 146 (Newark Road), a distance of 227.67 feet to a point;

thence North 21° 39' 25" East, along the East line of a tract conveyed to The Zanesville Country Club as Tract Six of a deed recorded in Deed Book 327, page 627 and passing an axle found at a distance of 24.46 feet, a total distance of 391.93 feet to an iron pin set;

thence North 02° 55' 55" East, continuing along the East line of said The Zanesville Country Club tract, a distance of 549.65 feet to a 5/8 inch rebar found;

thence South 86° 53' 55" East, along the South line of the aforementioned The President and Board of Trustees of Ohio University tract, a distance of 215.78 feet to the place of beginning.

Containing 5.0297, subject to all legal road right of way and any valid and existing easements, restrictions, leases or other conditions of record.

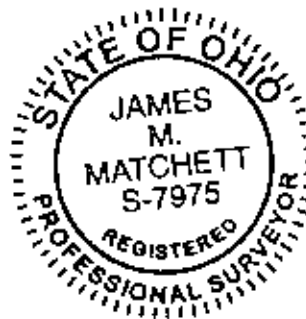
