PART OF AUDITORS PARCEL  
17-80-03-14-000 (PART 1.20 ACRES)

Situated in Quarter Township 3, T-1-N, R-8-W, U.S.M.L., Falls Township, Muskingum County, Ohio. Being part of the lands of Arnel and Lorene Dolen conveyed in Deed Book 455 Page 163 of the Muskingum County Deed Records, and being described as follows:

Commencing at a point at the intersection of Falls/Hopewell line with the centerline of Pinecrest Drive, which is located S.87°45'22"E. a distance of 6.08 feet from the intersection of Kimes and Pinecrest Drive; Thence, S.03°20'58"E. a distance of 625.53 feet along the West line of falls township and along the roadway of Kimes Road to a point, being the point of beginning;

Thence, **N.88°43'36"E.** a distance of **215.42** feet through the lands of A. & L. Dolen (455/163) to a set rebar on the West line of the lands, now or formerly, owned by C. Shuey (1561/387), passing a set rebar at 10.00 feet;

Thence, **S.03°20'12"E.** a distance of **242.65** feet along said Shuey lands to a set rebar;

Thence, **S.88°43'35"W.** a distance of **215.42** feet through the lands of A. & L. Dolen (455/163) to a point on the East line of Falls Township, located in the roadway of Kimes Road passing a set rebar at 205.42 feet;

Thence, **N.03°20'12"W.** a distance of **242.65** feet along said Township line to the point of beginning.

The above described parcel contains 1.20 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

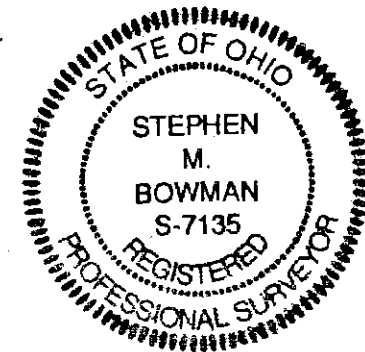
