Situated in the State of Ohio, County of Muskingum, Township of Falls, Quarter Township #3, Township #1, Range #8 of the US Military District:

Being a part of the prior deed reference Volume 531, Page 841 of said county's records, of which a portion is part of Lot #1 of Monroe and Duncan's Subdivision as recorded in Deed Book Volume "P", Page 519, also being a part of Muskingum County Auditor's Parcel Number 17-17-82-01-23-000, and more particularly described as follows;

Beginning at an iron pipe (found) at the most Southern corner of Lot #6 of Kings View Subdivision as recorded in Plat Book 14, Pages 19 and 20;

- #1- thence along the common line between said Lot #6 and the prior deed reference N 75 44 48 E 184.59 feet to the most Western corner of the F & D Taylor property as described in deed reference Volume 754, Page 272, from which an iron pipe (found) at the common corner for said Lot #6 and Lot #5 also of Kings View Subdivision bears for reference N 75 44 48 E 100.42 feet;
- #2- thence along a line of said Taylor property S 22 08 37 E 157.60 feet to an iron pipe (found) at a common corner of said Taylor property and the Donald Urban property as described in deed reference Volume 1049, Page 302, passing an iron pipe (found) at 3.16 feet;
- #3- thence along a line of said Urban property S 08 57 56 W 120.39 feet to an iron pin (found);
- #4- thence continuing along said Urban property passing out of said Lot #1 of Monroe and Duncan's Subdivision S 50 53 07 E 179.17 feet to an iron pin (found) at a common corner of said Urban property and a 1.331 acre parcel as surveyed from the prior deed reference by Joe Biedenbach RS #5718 completed on 5/31/1991;
- #5- thence along a line of said 1.331 acre parcel S 03 08 07 E 109.02 feet to an iron pin (found);
- #6- thence continuing along said 1.331 acre parcel S 44 40 35 E 291.86 feet to the center of Dillon Falls Drive (County Road #144), passing an iron pin (found) at 269.46 feet;
- #7- thence along the center of said road S 29 44 50 W 40.72 feet;
- #8- thence through said prior deed reference and along a common line of a 4.678 acre parcel surveyed from the prior deed reference by Charles R. Harkness RS #6885 completed on February 5, 1992 N 60 15 10 W 43.60 feet to an iron pin (set);

- #9- thence continuing through said prior deed reference, along a common line with said 4.678 acre parcel and passing into said Lot #1 N 40 13 04 W 475.42 feet to an iron pin (set);
- #10- thence continuing through said prior deed reference and along a common line with said 4.678 acre parcel N 43 51 01 W 237.35 feet to an iron pin (set);
- #11- thence continuing through said prior deed reference and along a common line with said 4.678 acre parcel N 17 24 47 W 134.56 feet to the place of beginning containing 1.775 acres of which 1.183 acres are within said Lot #1 of Monroe and Duncan's Subdivision.

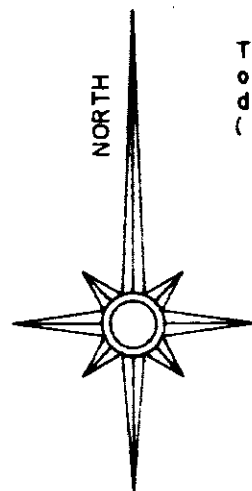

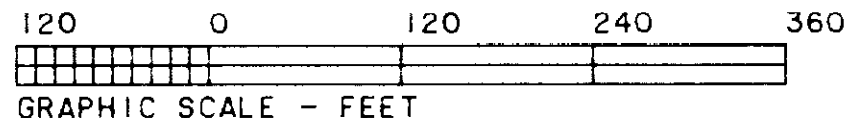
