ALL OF AUDITORS PARCELS
17-82-02-62-000
17-82-02-63-000 (4.05 ACRES)

Situated in Quarter Township 3, T-1-N, R-8-W, U.S.M.L., Falls Township, Muskingum County, Ohio. Being the lands of Bernard and Bonnie Drake conveyed in deed book 1644 page 823 of the Muskingum County deed records, and being described as follows:

Beginning at a point in the Old centerline of U.S. 40, located 20.00 feet left of centerline station 1155+90.24 as recorded in right of way plans for U.S. 40 (MUS-40-0.00);

Thence, **N.10°06'38"E** a distance of **774.57** feet along the lands, now or formerly, owned by J. & V. Unger (783/091) to a 30" Maple Tree, passing a set rebar at 40.57';

Thence, **S.79°40'38"E**. a distance of **140.91** feet along said Unger lands to a found iron pin, passing a set rebar at 5.00';

Thence, **S.08°55'52"E**. a distance of **384.93** feet along said Unger lands to A found iron pin;


Thence, **S.11°05'05"W**. a distance of **366.00** feet along said Unger lands to a point in the center of Old U.S. 40, located 20.00' left of new U.S. 40 centerline station 1158+54.24, passing a found iron pin at 324.23';

Thence, **N.89°32'07"W**. a distance of **264.00** feet along the old centerline, being 20.00 feet left of and parallel to new U.S. 40, to the point of beginning.


