Situated in the State of Ohio, County of Muskingum, Township of Falls, bounded and described as follows:

Being a part of the South Half of Quarter Township 3, Township 1 North, Range 9 West, United States Military Lands and being more particularly described as follows:

Beginning for reference at an iron pipe found on the northwest corner of Lot 31 of Westwood Hills as the same is designated and delineated on Muskingum County Plat Book 13, Pages 19 and 20; thence along the east right of way of Hillview Drive and the west line of Lot 31 of said Westwood Hills South 06 degrees 15 minutes 00 seconds West 224.23 feet to an iron pin set and the principal place of beginning; thence South 83 degrees 44 minutes 57 seconds East 362.86 feet to an iron pin set on the west line of Lot 22 of said Westwood Hills and lands now owned by W. Graham (Deed Record 685-54); thence along the west line of said Lot 22 South 06 degrees 13 minutes 00 seconds West 166.12 feet to an iron pipe found on the southwest corner of said Lot 22 and the north right of way of West Drive; thence along said north right of way South 83 degrees 43 minutes 00 seconds West 371.82 feet to an iron pin set on the east right of way of Hillview Drive; thence along said east right of way North 06 degrees 15 minutes 00 seconds East 246.81 feet to the principal place of beginning; containing 1.72 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Iron pins set are 5/8 inch by 30 inch long rebar with a plastic identification cap.

Bearings are based on the West line of Lot 31 of Westwood Hills as designated and delineated on Muskingum County Plat Book 13, Pages 19 and 20, as bearing South 06 degrees 15 minutes 00 seconds West.

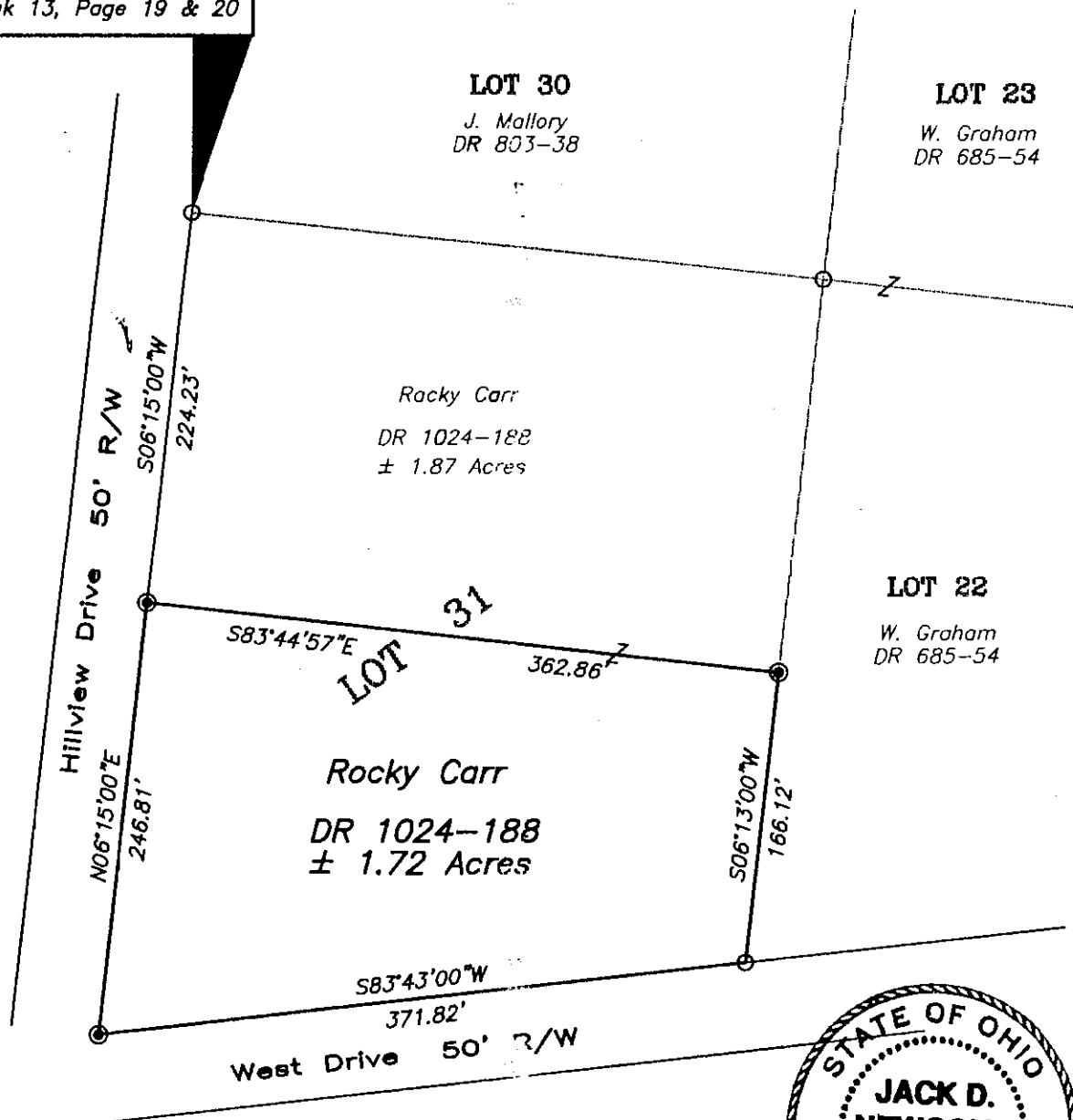
