

Being a part of Quarter Township 3, Township 1, Noe 8 bounded and ibed as follows: Commencing at the southeast corner of said o a point d 4 degrees 45 minutes east along the east line of said quarter township, 2745 feet to a point in the center of U. S. Route No. 40 at Station 1216+31.50 of the centerline survey of said road; thence north 69 degrees 11 minutes west along the center of said road, 2343.53 feet to a point; thence on a curve to the left having a radius of 7161.97 feet an arc length of 155.25 feet (the chord of which bears north 69 degrees 48 minutes west 155.24 feet) to a point in said centerline and the true place of beginning of the premises herein intended to be described; thence south 4 degrees 50 minutes west 542.90 feet to an iron pin; thence north 85 degrees 10 minutes west 40 feet to an iron pin; thence south 4 degrees 50 minutes west 122.70 feet to a point in the center of Timber Run; thence up said Timber Run north 81 degrees 02 minutes west 540.16 feet to a point; thence leaving said creek north 4 degrees 52 minutes 03 seconds east 753.55 feet to a point in the center of the aforesaid U. S. Route 40; thence along said centerline on a curve to the right having a radius of 7161.97 feet an arc distance of 592.23 feet (the chord of which bears south 72 degrees 47 minutes 37 seconds east 592.06 feet) to the true place of beginning, containing nine and thirty-seven hundredths (9.37) acres more or less.


