CENTERLINE SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO
BE DESCRIBED, SAID POINT BEING THE SOUTHWEST CORNER OF A TRACT CONVEYED TO R.
DODSON (DEED VOLUME 1562, PAGE 546);

THENCE CONTINUING WITH SAID CENTERLINE, NORTH 75 DEGREES 19 MINUTES 28 SECONDS
WEST 249.01 FEET TO A POINT;

THENCE LEAVING SAID ROAD AND WITH THE EAST LINE OF A TRACT CONVEYED TO J. MAYLE.
(DEED VOLUME 1548, PAGE 116) AND J. AND S. McINTURF (DEED VOLUME 986, PAGE 485), NORTH
02 DEGREES 33 MINUTES 27 SECONDS EAST 539.87 FEET TO AN IRON PIN SET, PASSING EXISTING
IRON PINS (3/4 INCH PIPE) AT 40.79 AND 257.77 FEET;

THENCE SOUTH 74 DEGREES 33 MINUTES 17 SECONDS EAST 166.45 FEET TO AN EXISTING AXLE;
