COMMENCING AT THE NORTHWEST CORNER OF LOT NUMBER FIVE AS DESCRIBED IN THE CASE OF JOHN REDMAN, AS ADMINISTRATOR OF THE JAMES RICHEY ESTATE, AGAINST JOHN RICHEY, et. al. AS RECORDED IN COMMON PLEAS COURT RECORDS, IN VOLUME X, PAGE 80 AND VOLUME Y, PAGE 480 OF MUSKINGUM COUNTY;

THENCE NORTH 73 DEGREES 47 MINUTES 53 SECONDS WEST 93.35 FEET ALONG THE CENTER OF COUNTY ROAD 420 (OLD NATIONAL ROAD) TO A POINT, SAID POINT BEING THE **PLACE OF BEGINNING** OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

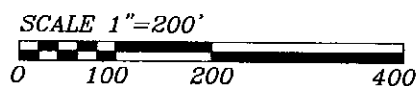
