

Survey for Zanesville Terrace Properties, LTD.

Being a part of land located in the State of Ohio, County of Muskingum, Falls Township, part of Quarter Township 4, Township 1 North, Range 8 West, United States Military Lands. Being part of the lands conveyed to Zanesville Terrace Properties, LTD., Muskingum County, Ohio in Deed Record 2212, page 246, bounded and described as follows:

Beginning at an iron pin found at the southwest corner of Lot 208 of Licking View Sudivision, (Plat Book 5, page97);

thence along the south line of Lot 208 South 57 degrees 53 minutes 52 seconds East 310.47 feet to a survey nail found in a log, also being the northwest corner of the Board of County Commissioners, Muskingum County, Ohio (DR 2284-526);

thence leaving the said south line of Lot 208 and along the west line of the Board of County Commissioners, Muskingum County, Ohio (DR 2284-526) South 22 degrees 12 minutes 09 seconds West 243.44 feet to an iron pin found, being the northwest corner of Board of County Commissioners, Muskingum County, Ohio (DR 1074-379);

thence along the west line of Board of County Commissioners, Muskingum County, Ohio (DR 1074-379) South 22 degrees 12 minutes 09 seconds West 539.19 feet to a point, being the southwest corner of Board of County Commissioners, Muskingum County, Ohio (DR 1074-379), an iron pin found bearing South 57 degrees 06 minutes 03 seconds East 12.15 feet;

thence along the west line of Coralie Wilson (DR 1062-525) South 22 degrees 12 minutes 09 seconds West 88.88 feet to an iron pin set;

thence leaving the west line of Coralie Wilson (DR 1062-525) and thru the property of Zanesville Terrace Properties, LTD. (DR 2212-246) North 57 degrees 06 minutes 03 seconds West 449.78 feet to an iron pin set on a line of Leroy and Delores Snider (DR 1110-22);

thence along said line of Leroy and Delores Snider (DR 1110-22) North 27 degrees 35 minutes 44 seconds East 248.88 feet to a point, an iron pin found bearing North 82 degrees 33 minutes 41 seconds West 0.60 feet, being the southeast corner of Leroy and Doris Snider (DR 1894-835);

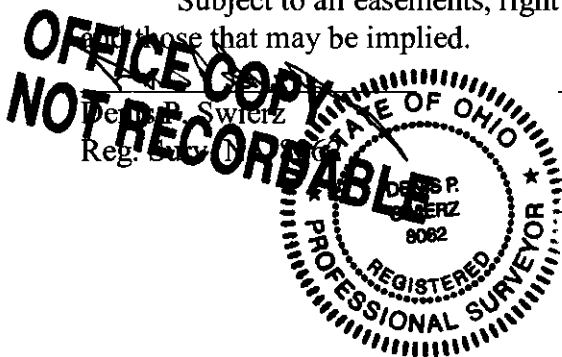

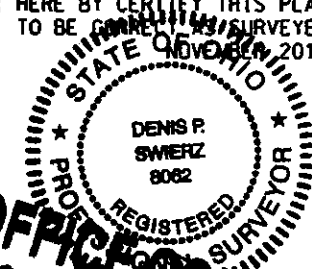
