

DESCRIPTION OF SURVEY FOR E & S STRAUSS

Situated in the State of Ohio, County of Muskingum, Township of Falls:

Being part of the Fourth Quarter Township, of Township #1, Range #8, of the US Military District, **being part of** the T Pinkerton property described in deed reference Deed Book Volume 1096, Page 441 of said county's deed records, known as Muskingum County **Auditor's Parcel Number 17-98-02-13-000**, and more particularly described as follows;

Commencing at an iron pipe (found) at the Southern corner for Lot #123 of Licking View as recorded in Plat Book 5, Page 93, also being the Northern intersection of Rehl Road (County Road #472) and Highland Road; **thence S 45 57 40 W 981.26 feet** along the Northwestern line of Rehl Road to an iron pipe (found) at a common corner for the Muskingum County Board of Commissioners property recorded in deed reference Deed Book Volume 658, Page 334 and the E & S Strauss property recorded in deed reference Deed Book Volume 537, Page 271; **thence S 19 14 00 W 218.60 feet** continuing along the West line of Rehl Road to a common corner for said Strauss property and for the T Pinkerton property recorded in deed reference Deed Book Volume 1096, Page 441, also being the place of beginning for the property herein intended to be described;

- #1- **thence S 19 14 00 W 20.99 feet** continuing along the West line of Rehl Road to an iron pin (set);
- #2- **thence N 61 27 00 W 84.09 feet** through said Pinkerton property to the common line of said Pinkerton and Strauss properties;
- #3- **thence S 75 50 40 E 83.31 feet** along the common line for said Pinkerton and Strauss properties to the place of beginning, **containing 0.02 acres.**

The bearings within this description are based on the Southeast line of the E & S Strauss property as described in deed reference Deed Book Volume 537, Page 271. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

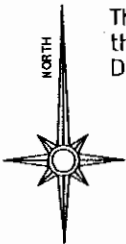

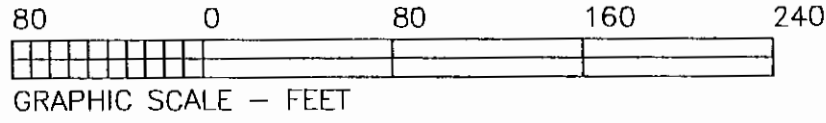

The bearings on this plat are based on the Southeast line of the E & S Strauss property as described in deed reference Deed Book Volume 537, Page 271.



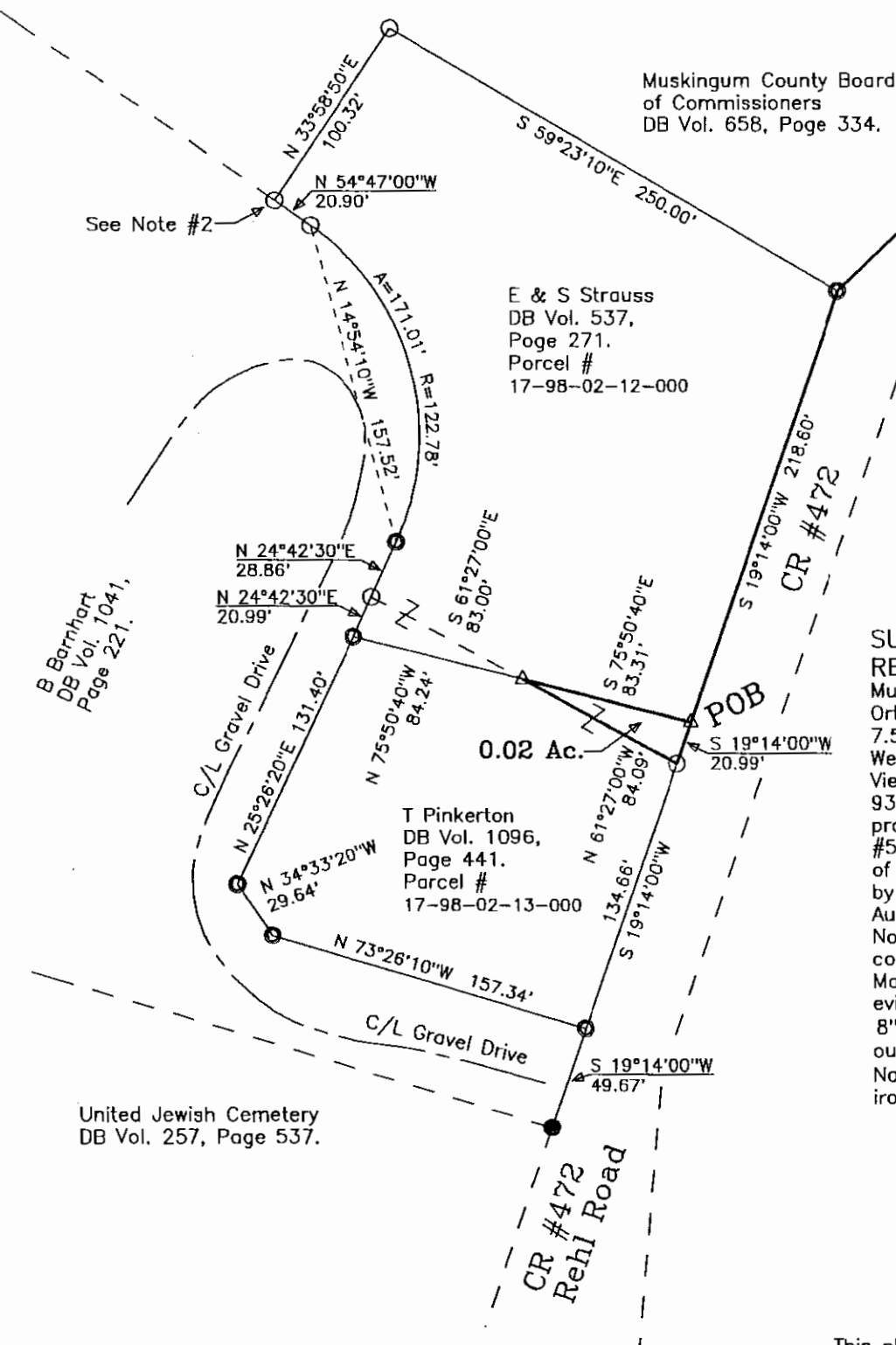
