

- 9) North 24 degrees 34 minutes 46 seconds East 366.89 feet to a point;
- 10) a curve to the right having a radius of 50.00 feet, a central angle of 94 degrees 05 minutes 48 seconds and a chord bearing North 71 degrees 37 minutes 40 seconds East 73.19 feet to a point;
- 11) South 61 degrees 21 minutes 28 seconds East 584.30 feet to a point;
- 12) a curve to the left having a radius of 888.83 feet, a central angle of 09 degrees 52 minutes 04 seconds and a chord bearing South 66 degrees 17 minutes 30 seconds East 152.89 feet to a point on the north line of lands now owned by Zanesville County Club (DR 327-627);

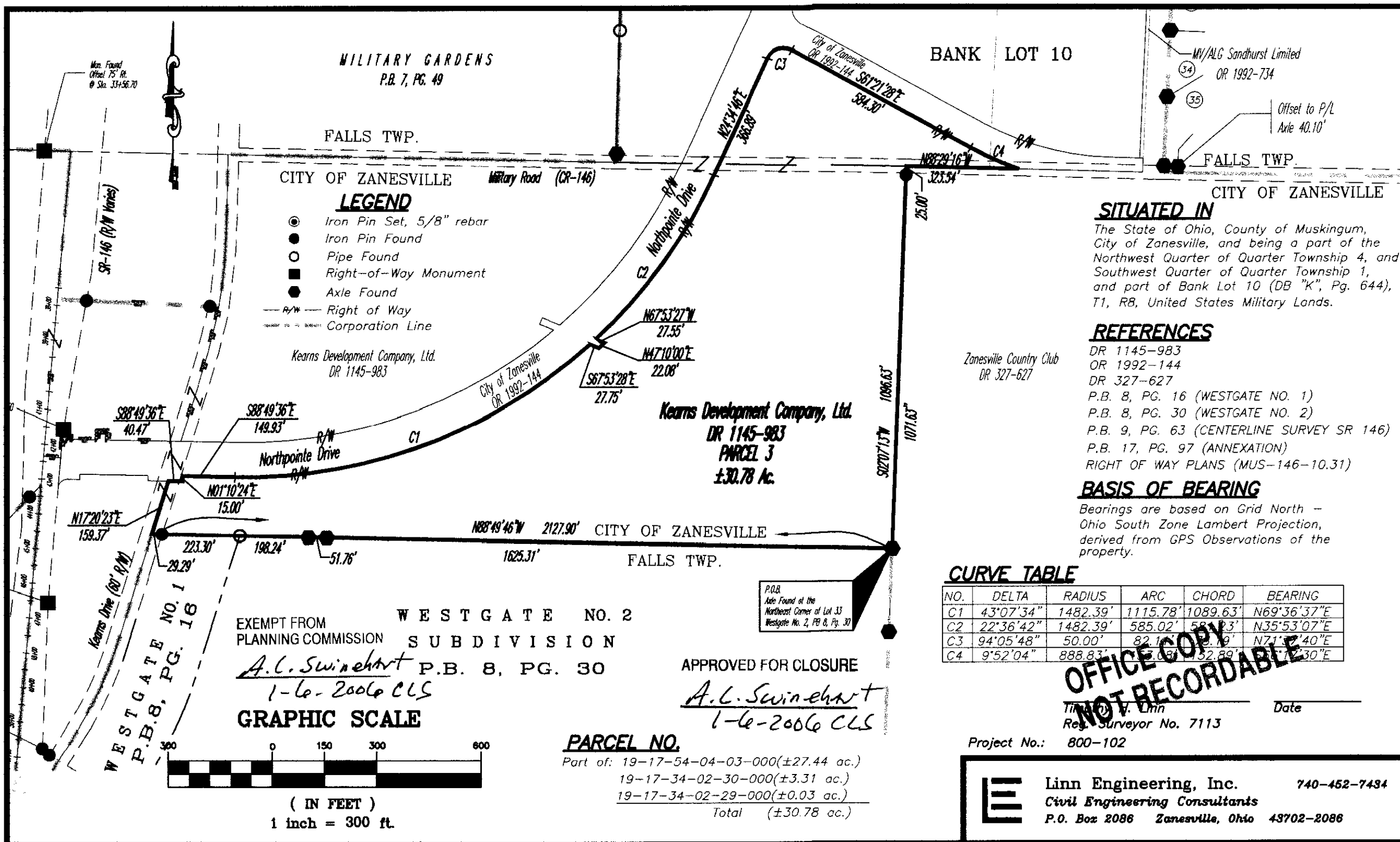
