Situated in Quarter Township #2, T-1, R-7, Falls Township, Muskingum County, Ohio. Being part of lots 110 and 111 of Home Acres Allotment, recorded in Plat book 7 page 10 and 11 of the Muskingum County plat records and being described as follows:

Commencing at the Southwest corner of lot #111; thence, N.04°50'00"E. a distance of 90.69 feet along the West line of said lot to a set rebar, BEING THE POINT OF BEGINNING;

thence, N.04°50'00"E. a distance of 153.54 feet along the west line of said lot to a found rebar on the Southwest corner of the lands, now or formerly, owned by W. & F. Bushue (1120/603);

thence, S.84°04'44"E. a distance of 196.42 feet along the south line of said Bushue lands to a found rebar on the west line of Dale Road;

thence, S.05°23'00"W. a distance of 142.59 feet along said road to a point;

thence, N.87°17'19"W. a distance of 195.16 feet through the lands of D. & H. Bates (1078/143) to the point of beginning, passing set rebars at 13.07 feet and 70.69 feet.

The above described parcel contains 0.665 acres, more or less, (0.404 acres in lot #110 and 0.261 acres in lot #111) and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars. North is based on an assumed meridian.

Situated in Quarter Township #2, T-1, R-7, Falls Township, Muskingum County, Ohio. Being part of lots 110 and 111 of Home Acres Allotment, recorded in Plat book 7 page 10 and 11 of the Muskingum County plat records and being described as follows:

Beginning at a set rebar on the Southwest corner of lot #111;  
thence, N.04°50'00"E. a distance of 90.69 feet along the west line of said lot to a set rebar;  
thence, S.87°17'19"E. a distance of 195.16 feet through the lands of D. & H. Bates (1078/143) to a point on the West side of Dale Road, passing set rebars at 124.47 feet and 182.09 feet;  
thence, S.05°23'00"W. a distance of 97.92 feet along said road to a set rebar on the Northeast corner of lot #109;  
thence, N.85°10'00"W. a distance of 194.08 feet along the North line of lot 109 and lot 108 to the point of beginning.

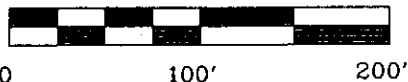

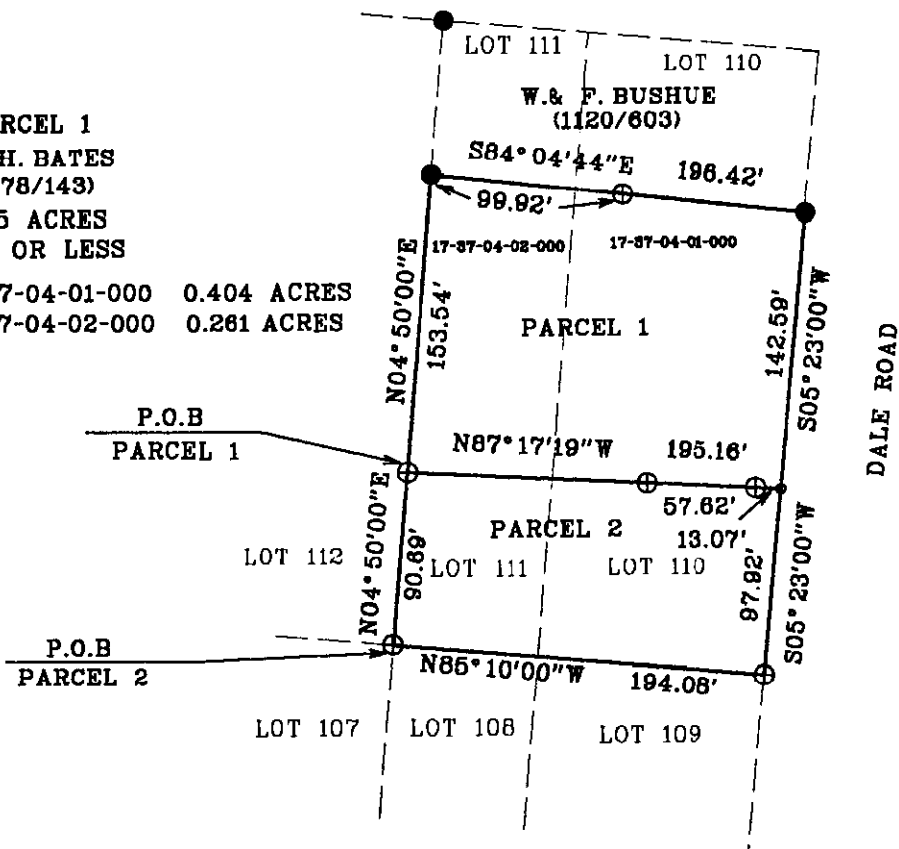
