DESCRIPTION OF SURVEY FOR E JEANNIE YOUNG

Situated in the State of Ohio, County of Muskingum, Township of Falls:

Being the remaining portion of Lot 24A of a Subdivision of Lot 24 Willow Lakes, recorded in Plat Book 8, Page 1B, further **being the remainder** of the E Jeannie Young property recorded in Official Record Volume 2110, Page 887 of said county's deed records, further **being the remainder** of Muskingum County **Auditor's Parcel Number 17-39-02-26-000**, and more particularly described as follows;

Beginning at an iron pipe (found) at the Northwest corner of said Lot 24A, also being on the Eastern line of a right of way platted by said subdivision;

- #1- **THENCE South 87 degrees 09 minutes 10 seconds East 260.55 feet** along the North line of said Lot 24A to an axle (found) at an angle point on the North lines of said Lot 24 and subdivision;
- #2- **THENCE South 08 degrees 38 minutes 10 seconds East 94.37 feet** crossing said Lot 24A to an iron pin (set) on the common line for Lots 24A and 24B of said subdivision;
- #3- **THENCE South 71 degrees 43 minutes 55 second West 181.25 feet** along the common line for said Lots 24A and 24B to an iron pipe (found) on the Eastern line of said right of way;
- #4- **THENCE North 32 degrees 05 minutes 55 seconds West 192.47 feet** along the common line of said Lot 24A and right of way to the place of beginning, **containing 0.67 acres.**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

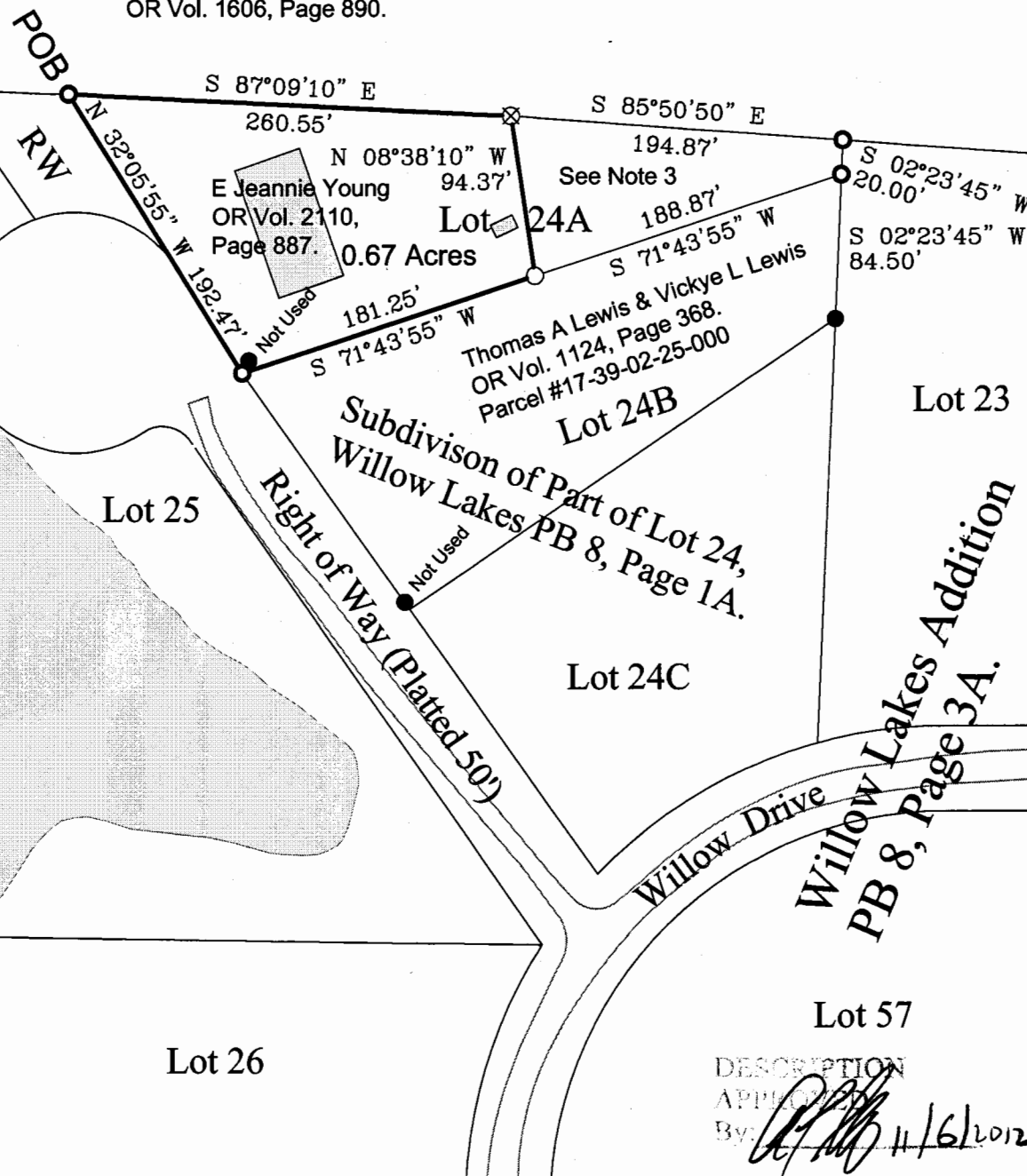
