Situated in the State of Ohio, County of Muskingum, Township of Harrison, Township 13, Range 12, Section 31, Village of Taylorsville (Philo), being Lots 8, 9 and 10 of Square 12, vacated part of Broadway Street along Lot 8 and vacated sidewalk along said lots, bounded and described as follows:

Commencing at the intersection of the West line of Front Street and the South line of Third Street at the corner of public square; thence North $80^{\circ} 00' 00''$ West along Third Street 821.00 feet to a point, the place of beginning; thence along the West line of a 15.00 foot wide alley and East line of Lot 10 South $10^{\circ} 00' 00''$ West 124.50 feet to an iron pin set; thence along the South line of Lots 10, 9, 8 and the vacated part of Broadway Street North $80^{\circ} 00' 00''$ West 278.00 feet to an iron pin set, passing the South ^{west} corner of Lot 8 at 198.00 feet; thence along the West line of vacated Broadway Street North $10^{\circ} 00' 00''$ East 124.50 feet to an iron pin set on the South line of Third Street; thence along Third Street South $80^{\circ} 00' 00''$ East 80.00 feet to an iron pin set at the Northwest corner of Lot 8; thence North $10^{\circ} 00' 00''$ East 9.00 feet to an iron pin set; thence along the vacated sidewalk along Lot 8, 9 & 10 South $80^{\circ} 00' 00''$ East 198.00 feet to an iron pin set; thence South $10^{\circ} 00' 00''$ West 9.00 feet to the Northeast corner of Lot 10, the place of beginning, containing 0.836 acres more or less.

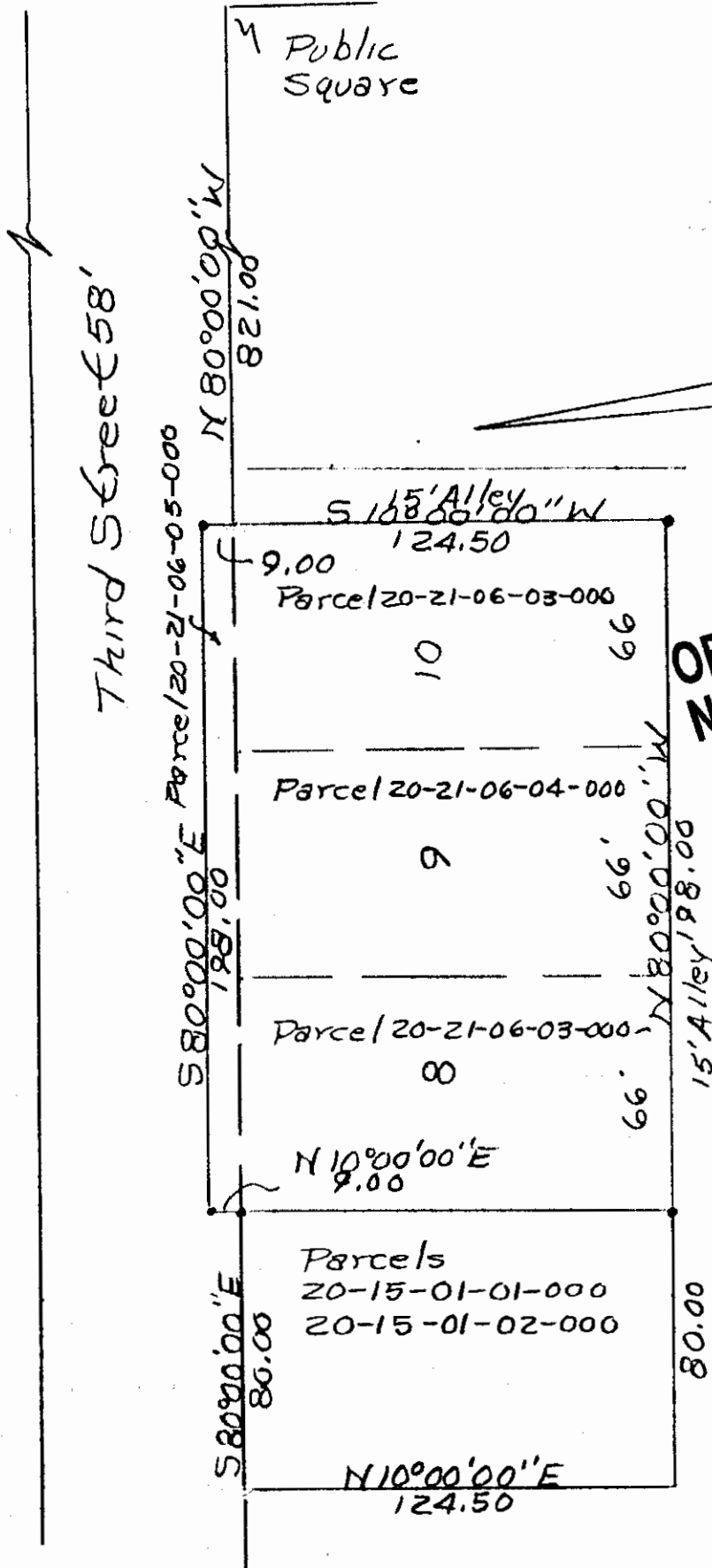
