Commencing at a stone found on the northeast Corner of Section 20 (Grid Coordinates N 674,702.25, E 2,130,067.65), thence along the east section line of Section 20 South 01°54′45″ West, a distance of 709.99 feet to the centerline of Irish Ridge Road (County Road 32) and the southerly line of a parcel of land now or formerly conveyed to Mark and Shanie Merew, by a deed recorded in Official Record 1649, Page 266 of the records of the Muskingum County Recorder's Office, passing a 2 inch diameter pipe at 319.70 feet, and a 5/8 inch rebar found capped "RA JANES, RS 006029" at 693.89 feet;

Thence along the centerline of Irish Ridge Road (County Road 32) the following 2 courses:

- 1. South 68°50'00" West, a distance of 461.10 feet to a point
- 2. South 58°32′14" West, a distance of 197.37 feet to a point found at N 674,701.91, E 2,130,067.63, the POINT OF BEGINNING of the parcel herein described.

Thence leaving said Irish Ridge Road along the easterly line of the subject parcel and the westerly line of a parcel of land now or formerly conveyed to Thomas J (Jr) and Betty J Bailey, by a deed recorded in Official Record 2016, Page 145 of the records of the Muskingum County Recorder's Office South 22°29′10″ East, a distance of 332.62 feet to a point in the center of Duncan Run, also being the northerly line of a parcel of land now or formerly conveyed to Karen A Groves, by a deed recorded in Official Record 2496, Page 231 of the records of the Muskingum County Recorder's Office, passing an axle found at 24.61 feet and a 1 inch diameter bar at 290.50 feet;
