Situate in the Township of Harrison, County of Muskingum, State of Ohio, and being a part of the Northwest Quarter of Section 6, Twp.-12N, Rng.-12W of the Congress Lands East of the Scioto River and being more particularly described as follows,

Being a re-survey of a portion of a parcel (Auditors P.P.N. 20-40-06-08-000) conveyed to Matthew D. Swingle and Robert Cook by Deed Volume 1155 page 276 in the record of deeds in the Muskingum County Recorders Office and being further described as follows,

Commencing, for reference, at an iron pin found (capped Harkness #6885) marking the Southeast corner of the Northwest Quarter of Section 6 in Harrison Township, Thence, **N 05° 48' 56" E** along the half Section line **2454.22** feet to a point, said point being referenced by a concrete monument found bearing **S 78° 51' 45" W 2.31** feet therefrom, Thence, along a curve to the right having a **Radius of 854.02** feet and a **Chord Bearing S 80° 43' 43" W** at a **Chord Distance of 39.70** feet to an iron pin found (capped Harkness #6885), Thence, **S 82° 02' 34" W 66.11** feet to a point in Duncan Run Creek, Thence, along the meanderings of Duncan Run Creek the following Eight (8) courses and distances;

- 1) **S 17° 27' 26" W** leaving the South line of Ohio Power Company **190.87** feet;

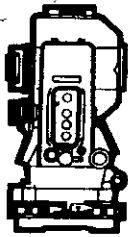

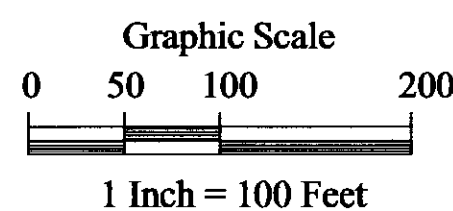

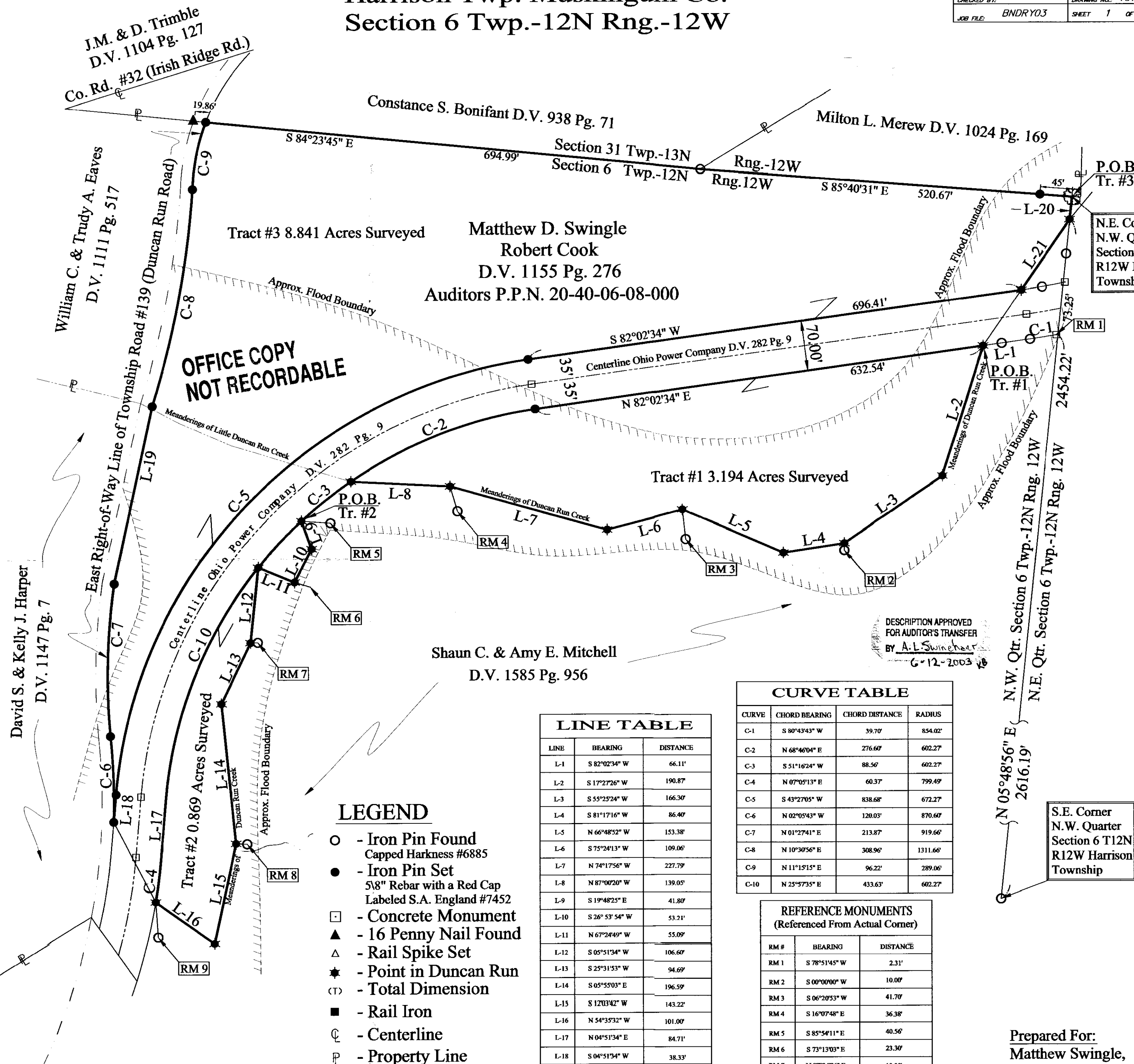
