

DESCRIPTION OF SURVEY FOR SANDRA OSBORN

Situated in the State of Ohio, County of Muskingum, Township of Harrison:

Being part of the Southeast Quarter, of Section 30, of Township 11, Range 13, of the Congress Lands East of the Scioto River, further **being all of** the Sandra Osborn property recorded in the first parcel described in Deed Book Volume 1150, Page 369, of said county's deed records, further being all of Muskingum County **Auditor's Parcel Number 20-50-30-19-000**, and more particularly described as follows;


- Beginning at a stone (found) at the Southeast corner of Section 30 and for the Northeast corner of Section 2 of Township 10, Range 13 of said Congress Lands;
- #1- **THENCE North 87 degrees 13 minutes 00 seconds West 682.59 feet** along the common line for said Sections 2 and 30 to an iron pin (set) at the Southeast corner of the Mike Hughes and Doreen Hughes property recorded in Official Record Volume 2097, Page 59;
- #2- **THENCE North 19 degrees 38 minutes 50 seconds West 2927.79 feet** crossing said Southeast Quarter of Section 30 and along said Hughes property to an iron pin (set) on the common line for the Northeast and Southeast Quarters of Section 30;
- #3- **THENCE South 87 degrees 13 minutes 25 seconds East 1791.65 feet** along said Quarter Section line to a stone (found disturbed by fallen tree re-set) at the Northeast corner of the Southeast Quarter and Southeast corner of the Northeast Quarter of Section 30, passing an iron pin (set) at 419.68 feet being the common corner for the Sonny C Elson and Donna K Elson property recorded in Official Record Volume 2074, Page 505 and for the Michelle A Barstow and Jerry F Barstow property recorded in Deed Book Volume 1048 , Page 496;
- #4- **THENCE South 02 degrees 36 minutes 45 seconds West 2706.50 feet** along the East line of Section 30 to the place of beginning, passing a stone (found) at 344.34 feet, **containing 76.86 acres.**




