

Being a parcel of land located in Fractional Section No. 17, Town No. 14, Range No. 12, Harrison Twp., Muskingum Co. Ohio, being a part of Parcel No. 20-00368.

Commencing at the Southwest corner of the Northwest quarter of said Fractional section No. 17, - thence along the West line of said fractional South 180.42' to grantors South line; thence grantors South line and a fence S87°47'27" E 1649.88' to an Ironpin at the southeast corner of a 14.580 Ac. tract; thence leaving said south line and along the east line of 14.580 Ac. tract N27°30'20" W 353.06' to an Ironpin and the point of beginning; thence from this point of beginning continuing N27°30'20" W 376.95' to a point in the center of a private road (Ref: passing Iron pins at 28.93', 160.23' and 346.95'); Note: next (9) nine courses along private road N59°42'30" E 123.13'; N66°25'50" E 107.76'; N85°27'50" E 93.83'; N50°34'20" E 90.77'; N62°52'30" E 91.91'; S 85°46'50" E 232.27'; S69°01' E 102.50'; S42°05'40" E 134.54'; N78°18'30" E 142.71' to a point in the west line of Chessie System Parcel; thence leaving said road and along said west line S9°17'30" W 457.11' to an Ironpin; thence leaving said west line N87°47'27" W 760.50' to the point of beginning, containing 10.007 Ac.

The above described parcel subject to a 50' right of way, being 25' Lt 25' Rt of the following described centerline; beginning at a point in a private road and in the north line of above described parcel, said point being S 78°18'30" W 142.71' from the northeast corner of above parcel; thence leaving said north line S22°53' E 75.11'; S8°09' W 244.96'; S20°54'40" W 88.32' to the south line of above parcel.
