DESCRIPTION OF SURVEY FOR SANDRA OSBORN JOB#1496-3

Situated in the State of Ohio, County of Muskingum, Township of Harrison:

Being part of the Southwest Quarter, of the Southwest Quarter, of Section #18, Township #12, Range #12, of the Congress Lands East of the Scioto River, being a **survey intending to establish the line** between the Sandra Osborn property recorded in Deed Book Volume 1150, Page 369 covering Muskingum County Auditor's **Parcel Number 20-60-18-07-000**, and the John and Helen Harris property recorded in Official Record Volume 1520, Page 580, Muskingum County Auditor's **Parcel Numbers 20-60-18-08-000, 20-60-18-10-000, and 20-60-19-05-001**, and more particularly described as follows;


Beginning at an iron pin (found) at the common corner for the Northwest and Southwest Quarters of the Southwest Quarter, of said Section #18, also being on the common line for Ranges #12 and #13 of said Congress Lands;

- #1- **THENCE South 87 degrees 40 minutes 00 seconds East 822.40 feet** along the common line for said Quarter Quarter Sections to the unmarked Northwest corner of the D & B Dunkle property recorded in Official Record Volume 1561, Page 842;
- #2- **THENCE South 00 degrees 28 minutes 50 seconds West 1051.06 feet** into said Southwest Quarter of the Southwest Quarter and along the West line of said Dunkle property to an iron pin (set), passing an iron pin (found) at 0.38 feet;
- #3- **THENCE South 78 degrees 11 minutes 35 seconds West 253.69 feet** establishing the line between said Osborn and Harris properties to an iron pin (found);
- #4- **THENCE North 82 degrees 04 minutes 45 seconds West 617.01 feet** continuing to establishing the line between said Osborn and Harris properties to a stone (found) at the common corner for Section #2 of Township #10, Range #13, and for Section #30 of Township #11, Range #13 of said Congress Lands;
- #5- **THENCE North 02 degrees 32 minutes 05 seconds East 1052.40 feet** along said common Range and Section line to the place of beginning, **containing 20.91 acres.**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R. Harkness Professional Land Surveyor #6885 from an actual survey completed on April 18, 2006, in accordance with Chapter 4733-37 of the Administrative Code, and is intended to be used for establishment of common lines between the Sandra Osborn and John and Helen Harris properties and does not intend to describe all or any easements of record, nor encroachments unless otherwise indicated.


