

Description of Parcel 4

Situated in the State of Ohio, County of Muskingum, Townships of Harrison, being in the southeast quarter of Section 18, Range 12 West, Township 11 North, of "The Congress Lands East of The Scioto River" and being bounded and described as follows:

Commencing for reference at an iron pin set at the northwest corner of the northeast quarter of the southeast quarter of Section 18 (Note: Reference bearing on the north line of the northeast quarter of the southeast quarter of Section 18 used as South 89°52'56" East.);

thence, with the west line of the northeast quarter of the southeast quarter of Section 18, South 00°47'28" West a distance of 142.12 feet to an iron pin found capped "Janes 6029" at the southwest corner of a 6.99 acres tract as conveyed to Lazy Acres Farm, Inc. by Deed Volume 905, Page 157 of the Muskingum County Recorder's Office;

thence, leaving the quarter-quarter section line with the south line of said Lazy Acres Farm, Inc., North 89°54'54" East a distance of 259.00 feet to an iron pin set, being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning continuing with the south line of said Lazy Acres Farm, Inc., North 89°54'54" East a distance of 247.00 feet to an iron pin set;

thence, leaving said property line, South 01°24'29" East a distance of 1,152.99 feet to a point in the centerline of County Road No. 40, passing through two iron pins set at distances of plus 1,027.99 feet and plus 1,127.99 feet, respectively;

thence, with the centerline of County Road No. 40, the following three courses:

- (1) thence South 80°01'02" West a distance of 49.28 feet to a point;
- (2) thence South 85°25'03" West a distance of 148.77 feet to a point;
- (3) thence North 85°28'22" West a distance of 79.43 feet to a point;

thence, leaving the road, North 00°01'59" East a distance of 1,166.44 feet to the Point of Beginning, passing through two iron pin set at distances of plus 25.00 feet and plus 125.00 feet, respectively;

containing 7.004 acres, more or less, out of Parcel Number 20-20-60-18-17-000.
