Commencing at the northeast corner of the southwest quarter of Section 19; thence along the quarter section line south 1 degree 26 minutes 23 seconds east 692.67 feet to an iron pin; thence south 61 degrees 16 minutes 28 seconds west 208.58 feet to an iron pin; thence south 70 degrees 07 minutes 44 seconds west 183.07 feet to an iron pin; thence south 44 degrees 13 minutes 19 seconds west 171.92 feet to an iron pin; thence south 83 degrees 54 minutes 41 seconds west 109.15 feet to an iron pin found at the northwest corner of a 5.001 acre parcel conveyed to Dale and Kimberly Krause by deed recorded in Deed Book 1978, Page 614 and the true place of beginning of the premises herein intended to be described; thence along the west lines of said 5.001 acre parcel the following three (3) courses and distances south 30 degrees 37 minutes 53 seconds east 61.84 feet to an iron pin; thence south 17 degrees 20 minutes 38 seconds east 288.84 feet to an iron pin; thence south 2 degrees 26 minutes 07 seconds east 506.54 feet to an iron pin; thence north 5 degrees 44 minutes 27 seconds west 512.13 feet to an iron pin placed; thence north 15 degrees 06 minutes 59 seconds west 337.10 feet to the true place of beginning, containing thirty-three hundredths (0.33) of an acre more or less.
