Fractional Commencing at the Northeast Corner of the Southwest Quarter of Section 30; Thence North 85°23'46" West 262.89 feet to a point in center of Union Hill Road the place of beginning; Thence along the center of Union Hill Road and *Galyn Alexander* Vol. 1059 Page 367, the next 4 courses and distances: South 58°31'11" West 492.86 feet, South 59°33'00" West 333.67 feet to a point, South 51°25'49" West 74.64 feet to a point and South 52°03'54" West 31.98 feet to a point; Thence leaving center of Union Hill Road and along the split line of Harvey L. and Reva J. Ribble Vol. 425, Page 500, North 1°45'19" West 558.04 feet to an iron pin set passing an iron pin set at 21.00 feet; Thence South 85°23'46" East along *Galyn Alexander* Vol. 912, Page 119, 811.25 feet to the place of beginning passing an iron pin set at 781.25 feet containing 5.07 acres more or less:

Iron pins set are No. 5 rebar bars 36 inches long with plastic ID caps.

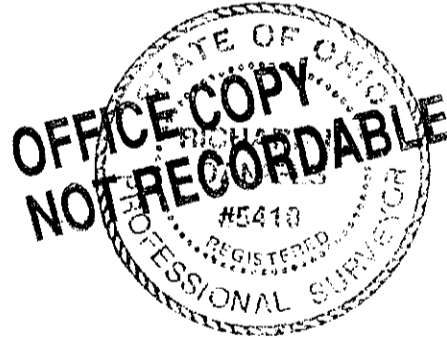
