degrees 48 minutes east along said centerline a distance of 873.59 feet
to a point; thence south 27 degrees 53 minutes east along said center
line a distance of 192.06 feet to a spike at the true place of beginning
for the parcel herein intended to be described; thence north 62 degrees
11 minutes east a distance of 49.13 feet to the low water mark of
the Muskingum River and passing through an existing iron pin at 34.13
feet; thence south 32 degrees 14 minutes east along said low water

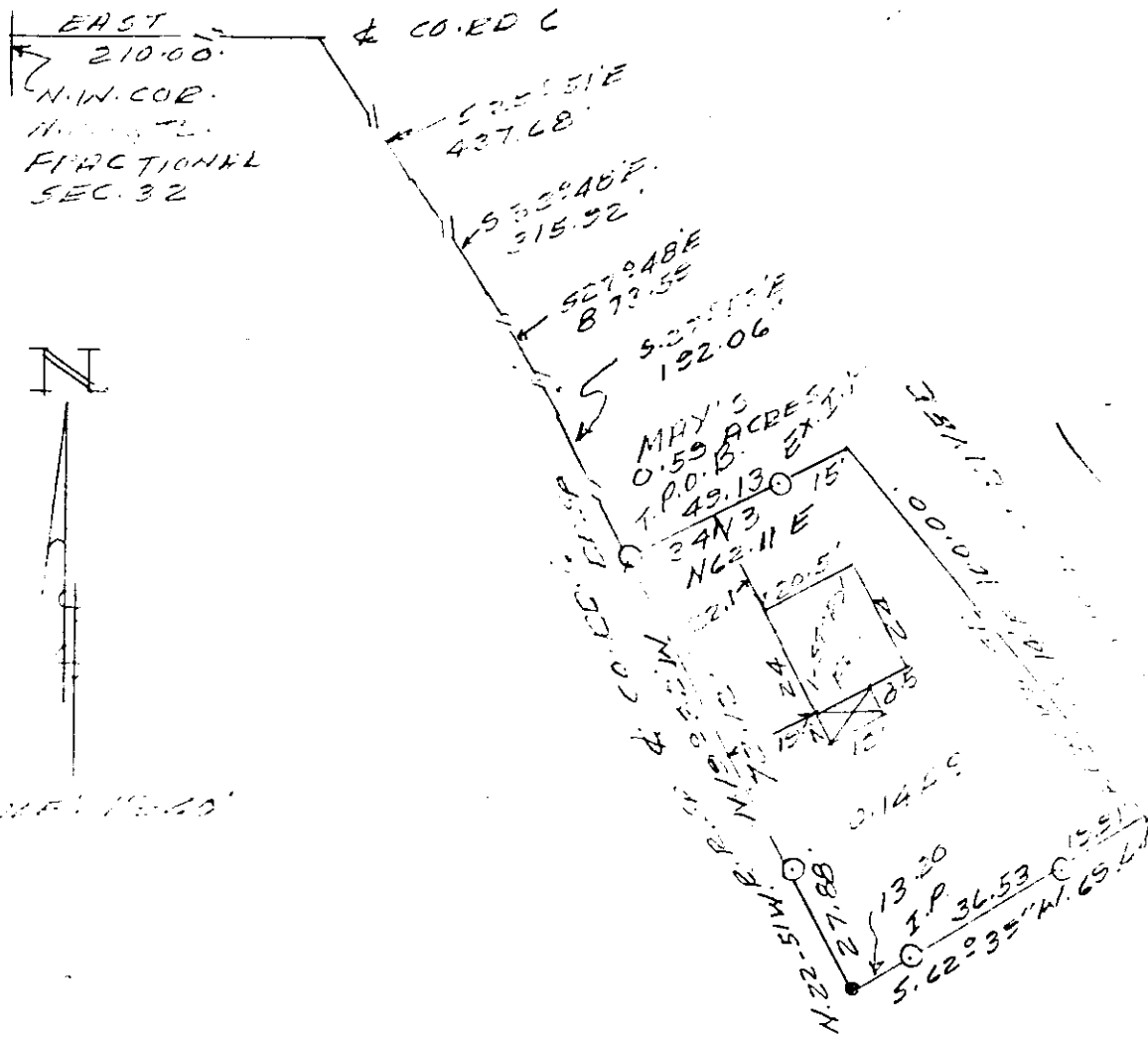
