Being a part of Fractional Section 32, T12, R12, Harrison Township, Muskingum County, also being all of the lands now owned by Shirley A. Moreland as recorded in OR 2934-681 of the Muskingum County Recorder's Office and more fully described as follows.

Beginning for reference at an iron pin found at the northwest corner of Section 32, thence S 36°33'46" E a distance of 2149.93 feet to a railroad spike found in the center of Old River Road (CR-6), the principal place of beginning;

Thence with the center of said Old River Road the following three (3) courses:

- 1. S 18°36'58" E a distance of 73.38 feet to a point;
- 2. S 19°03'10" E a distance of 45.95 feet to point;
- 3. S 25°11'42" E a distance of 53.89 to a railroad spike set on the southwesterly corner of the lands now owned by Janet F. Dunning (DR 1151-80);

Thence leaving the center of said Old River Road and going with the common line of said Moreland/Dunning's lands, N 58°36'53" E a distance of 71.40 feet to a point on the bank of the Muskingum River at the low water mark, passing an iron pin found at 39.02 feet;

Thence with said low water mark, S 29°40'03" E a distance of 101.59 feet to a point, being the northeasterly corner of the lands now owned by William Conner & Stephanie Carter (OR 2811-216);

Thence leaving the low water mark and going with the common line of said Moreland/Conner & Carter's lands, S 58°45'58" W a distance of 282.40 feet to a railroad spike set on the east line of the lands now owned by CSX Transportation Inc., formally B&O Railroad Co., being in the center of Cedar Run Road (T-243), passing an iron pin found at 45.32 feet and a railroad spike set at the center of the intersection of said Old River Road/Cedar Run Road;

Thence with the east line of said CSX Transportation Inc.'s lands, N 23°50'55" W a distance of 268.73 feet to a pipe found on the southwest corner of the lands now owned by Annabelle Tobin (OR 2758-674);

Thence with the southerly line of said Tobin's lands, N 57°24'43" E a distance of 210.69 feet to the place of beginning, containing 1.427 acres more or less, subject to all legal highways and easements of record.
