Commencing at a stone at the Southwest corner of Section 32; thence along the West line of Section 32 North $1^{\circ} 05' 30''$ East 1300.00 feet to an iron pin; thence South $88^{\circ} 54' 30''$ East 902.00 feet to an iron pin; thence North $80^{\circ} 44' 28''$ East 1537.32 feet to an iron pin; thence North $63^{\circ} 50' 28''$ East 80.75 feet to an iron pin set; thence North $26^{\circ} 15' 35''$ West 500.90 feet to an iron pin set, the place of beginning; thence North $26^{\circ} 15' 35''$ West 169.33 feet to an iron pin set; thence North $76^{\circ} 28' 49''$ East 236.93 feet to an iron pin set; thence North $64^{\circ} 44' 10''$ East 209.53 feet to the Muskingum River, passing an iron pin set at 169.17 feet and center of County Road 6 at 194.00 feet; thence along the water line of Muskingum River South $39^{\circ} 55' 20''$ East 116.74 feet to a point; thence leaving said river South $63^{\circ} 44' 25''$ West 468.37 feet to the place of beginning, passing an iron pin set at 42.03 feet and center of County Road 6 at 17.03 feet, containing 1.35 acres more or less.

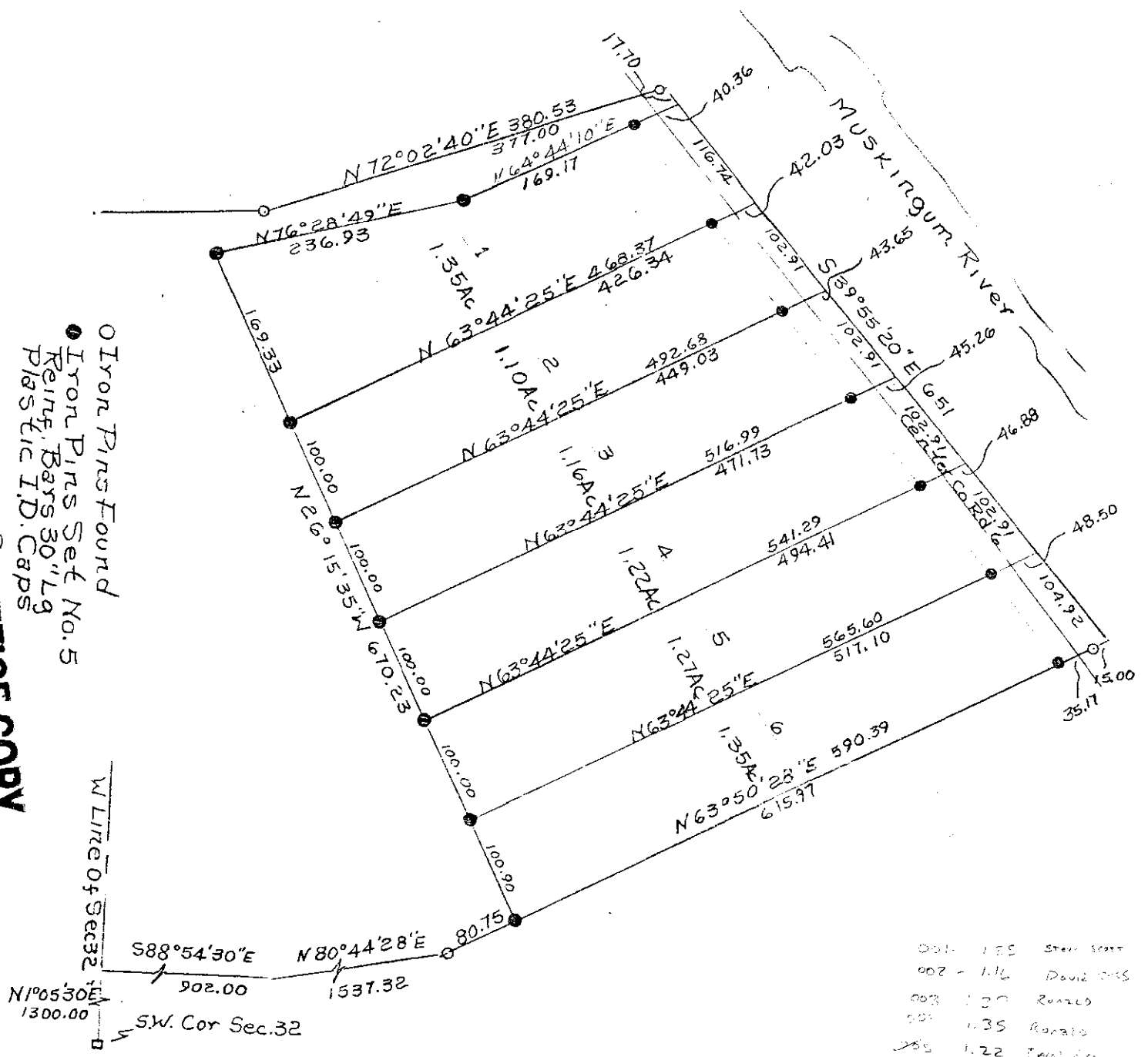
