

DEED DESCRIPTION FOR EMORY STRICKLER

Situated in Highland Township, Muskingum County, Ohio and being 167.713 acres more or less in the Northeast Quarter of Section # 3, and in the Southeast Quarter of Section # 3, Township # 2 North, Range # 5 West in the United States Military lands Survey and being more particularly described as follows:

BEGINNING at an iron pin found at the Northwest corner of the Northeast Quarter of Section # 3, Thence with the north line of the Northeast Quarter of Section # 3 and the lands of now or formerly Rick L. Barr as found in Volume 2084 Page 110, and the lands of now or formerly Gerald R. Bissonette as found in Volume 538 Page 806 S89°00'45"E a distance of 2601.68 feet to an iron pin set (having passed through an iron pin found at a distance of 1329.30 feet), Thence with the east line of the Northeast Quarter of Section # 3 and the lands of now or formerly Helen C. Hansel Trustee as found in Volume 1545 Page 733 the following two (2) calls:




