Situate in the State of Ohio, County of Muskingum, Township of Highland, and being part of the Northeast Quarter of Section # 8 in Township 2 North , Range 5 West of the United States Military District and being part of parcel # 23 - 50 - 08 - 01 as conveyed to Glenn and Jo Ann Starcher in Deed Volume 1124, Page 317, of the Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning at an iron pin found at the Northeast corner of the Section # 8 in Township 2 North , Range 5 West , thence along the North line of Section # 8 North 90 degrees 00 minutes 00 seconds West 22.73 feet to an iron pin set and the True Place of Beginning ; thence leaving said Section line, along a new line crossing Glenn and Jo Ann Starcher ' s parcel South 02 degrees 26 minutes 07 seconds West 296.29 feet to an iron pin set on a new line; thence crossing said Glenn Starcher 's parcel on a new line South 90 degrees 00 minutes 00 seconds West 221.98 feet to an iron pin set in Windy Ridge Road (Twp. Rd. # 102) ; thence along said road and the line between A. and F. Kaufman (Vol. 1130 Pg. 796) and said G. and J. Starcher North 02 degrees 55 minutes 14 seconds East 296.40 feet to an iron pin set on the north line of Section # 8 and in said road ; thence along said Section line South 90 degrees 00 minutes 00 seconds East 219.47 feet to an iron pin set and the place of beginning .

Containing 1.500 Acres, more or less , subject to all easements , restrictions , or right of ways , either written or implied. All iron pins set are 30 inch long by 5/8 inch diameter rebar with a yellow cap labeled "BINCKLEY S-7879".

Bearings contained herein are assumed on a previous survey by Jerry L. Gamble dated 9 - 12 - 1994 of the North line of Section # 8 as being South 90 degrees 00 minutes 00 seconds East and are for angular measurement only.
