Being a part of the NE Quarter of Section 8 and the NW Quarter of Section 9, T2, R5, Highland Township, Muskingum County, State of Ohio and being part of the lands now owned by Glenn E. Starcher (OR 2514-483) as recorded in the Muskingum County Recorders Office more particularly described as follows.

Beginning at an iron pin found at the NE corner of Section 8, thence with the south line of the lands now owned Lisa D. Clark (OR 1555-608), S 87°47'28" E, 198.00 feet to an iron pin found on the northwest corner of the lands now owned by The Ruby Family Trust (DR 1153-111);

thence with the west line of said The Ruby Family Trust's lands, S 04°38'39" W, 499.39 feet to a an iron pin set:

thence going leaving said west line and going through said Starcher's lands, N 87°47'30" W, 444.43 feet to a point in the western edge of the road bed of Windy Ridge Road (TR-102), passing into Section 8 at 176.09 feet and passing an iron pin set at 421.37 feet;

thence with the west line of said Starcher's lands, N 05°07'45" E, 203.19 feet to an iron pin found on the southwest corner of the land now owned by Nicholas L. Nash (OR 2706-828), passing an iron pin found 161.59 feet; thence with the common line of said Starcher/Nash the following tow (2) courses:

1. S 87°47'28" E, 221.82 feet to an iron pin found;

2. N 04°40'32" E, 296.29 feet to an iron pin found on the north line of said Section 8;

thence with the north line of said Section 8, S 87°47'28" E, 22.73 feet to the place of beginning, containing 3.567 acres more or less, subject to all legal highways and easements of record.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.
