

Harper & Eileen L. Barr, Trustees OR 2113-508 Tract Three, First Parcel +/-20.66 Ac.

Being a part of the Northwest Quarter of Section 9, Township 2, Range 5, Highland Township, Muskingum County, also being a part of the lands now owned by Harper & Eileen Barr, Trustees as recorded in Official Record 2113, Page 508, of the Muskingum County Recorder more fully described as follows.

Beginning at an iron pin found at the center of Section 9, thence South 01 degrees 43 minutes 53 seconds West, 163.22 feet to an iron pin found;

Thence North 31 degrees 21 minutes 16 seconds West, 196.29 feet to an iron pin set and the principal place of beginning for the tract of land described herein;

Thenc along the mid-section line also being a common line splitting the lands now owned by Harper & Eileen L. Barr (OR 2113-508, Tract Three, First Parcel), North 87 degrees 37 minutes 28 seconds West, 1210.81 feet to a corner post on the Southeast corner of the lands now owned by Dorothy N. Morrow (OR 1521-624);

Thence with the east line of said Morrow's lands, North 02 degrees 01 minutes 24 seconds East, 1217.43 feet to a railroad spike set in the center of Windy Ridge Rd. (T-102);

Thence with said centerline the following 8 courses:

- 1. South 72 degrees 50 minutes 27 seconds East, 184.86 feet to a point;
- 2. South 85 degrees 40 minutes 24 seconds East, 148.50 feet to a point;
- 3. South 71 degrees 37 minutes 35 seconds East, 60.79 feet to a point;
- 4. South 53 degrees 11 minutes 51 seconds East, 61.12 feet to a point;
- 5. South 42 degrees 54 minutes 04 seconds East, 62.35 feet to a point;
- 6. South 34 degrees 53 minutes 13 seconds East, 155.48 feet to a point;
- 7. South 41 degrees 42 minutes 36 seconds East, 225.54 feet to a point
- 8. South 43 degrees 38 minutes 15 seconds East 150.65 feet to a railroad spike found on the most northerly point of the lands now owned by Jason L. & Katrina D.

Derry (OR 1584-165);

Thence with the common line of said Derry's lands and the tract being described herein the following 3 courses:

- 1. South 37 degrees 17 minutes 58 seconds West, 273.80 feet to a iron pin found, passing an iron pin found at 20.00 feet;
- 2. South 47 degrees 39 minutes 53 seconds East, 685.19 feet to an iron pin found on the common corner of the lands now owned by Larry D. Barr (OR 2184-388), said Derry and the tract being described herein;

Thence with the lands of said Larry D. Barr, South 31 degrees 26 minutes 20 seconds East, 18.13 feet to the point of beginning, containing 20.66 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation on 06/18/2012.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.
