BEING THE REMAINDER OF THE FIRST PARCEL AND ALL OF THE SECOND AND THIRD PARCELS AS CONVEYED TO TOM D. DETWEILER AND NANCY A. FARGO IN DEED VOLUME 996, PAGE 194 OF THE MUSKINGUM COUNTY DEED RECORDS. SITUATED IN THE SOUTHWEST QUARTER OF SECTION 10, TOWNSHIP 2, RANGE 5, OF THE UNITED STATES MILITARY LANDS, HIGHLAND TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 10, SAID CORNER BEING IN THE ROADBED OF RUBY ROAD AND BEING NORTH 03 DEGREES 07 MINUTES 55 SECONDS EAST 29.00 FEET FROM AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE SOUTH LINE OF THE SAID SECTION 10 (NORTH LINE OF SECTION 11), NORTH 87 DEGREES 47 MINUTES 55 SECONDS WEST 1098.53 FEET TO A POINT IN THE ROADBED OF RUBY ROAD, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR -DISTURBED) IN THE SAID ROAD AT 728.77 FEET;

THENCE LEAVING THE SAID SECTION LINE AND WITH THE EAST LINE OF A PARCEL CONVEYED TO VERNA L. McNEAL IN DEED VOLUME 559, PAGE 292, NORTH 05 DEGREES 00 MINUTES 51 SECONDS EAST 403.98 FEET TO A POINT IN THE CENTER OF CAMBRIDGE ROAD (STATE ROUTE 209), PASSING AN EXISTING IRON PIN (1/2 INCH REBAR WITH "CLAUS" CAP) AT 16.71 FEET AND AN EXISTING HIGHWAY RIGHT OF WAY MARKER (CONCRETE MONUMENT WITH METAL DISK) AT 342.89 FEET;

THENCE WITH THE CENTER OF THE SAID CAMBRIDGE ROAD, NORTH 34 DEGREES 23 MINUTES 26 SECONDS EAST 43.11 FEET TO A POINT AT THE NORTHWEST CORNER OF A PARCEL CONVEYED TO JANE THOMPSON IN DEED VOLUME 80, PAGE 256;

THENCE WITH THE WEST, SOUTH, AND EAST LINES OF THE SAID THOMPSON PARCEL THE FOLLOWING THREE COURSES AND DISTANCES:

1. SOUTH 16 DEGREES 40 MINUTES 29 SECONDS EAST 115.50 FEET TO AN EXISTING IRON PIN (1/2 INCH REBAR - DISTURBED), PASSING AN EXISTING IRON PIN (1/2 REBAR - DISTURBED) AT 38.50 FEET;
2. NORTH 46 DEGREES 19 MINUTES 24 SECONDS EAST 149.88 FEET TO AN EXISTING IRON PIN (1/2 REBAR - DISTURBED);
3. NORTH 27 DEGREES 47 MINUTES 35 SECONDS WEST 136.62 FEET TO A POINT IN THE CENTER OF THE SAID CAMBRIDGE ROAD, PASSING AN EXISTING IRON PIN (1/2 REBAR - DISTURBED) AT 102.50 FEET;

THENCE WITH THE CENTER OF THE SAID CAMBRIDGE ROAD THE FOLLOWING 10 COURSES AND DISTANCES:

1. NORTH 34 DEGREES 23 MINUTES 26 SECONDS EAST 313.49 FEET TO A POINT, SAID POINT BEING SOUTH 55 DEGREES 36 MINUTES 34 SECONDS EAST 30.00 FEET FROM AN EXISTING IRON PIN (1/2 INCH REBAR - DISTURBED);
2. NORTH 33 DEGREES 13 MINUTES 54 SECONDS EAST 448.34 FEET TO A POINT;
3. NORTH 40 DEGREES 20 MINUTES 21 SECONDS EAST 144.37 FEET TO A POINT;
4. NORTH 46 DEGREES 58 MINUTES 55 SECONDS EAST 124.19 FEET TO A POINT;
5. NORTH 51 DEGREES 00 MINUTES 02 SECONDS EAST 90.32 FEET TO A POINT;
6. NORTH 54 DEGREES 35 MINUTES 24 SECONDS EAST 54.66 FEET TO A POINT;
