K. Nail set in the center of S. R. # 83 (having passed through an iron pin set at 164.84 feet, Thence with the center of S. R. # 83 S 75° 21' 46" W a distance of 64.24 feet to a P. K. Nail set, Thence with the lands of now or formerly Charles St. Clair as found in Volume 712 Page 66 of the deed records of Muskingum County, Ohio N 09° 33' 46" E a distance of 214.24 feet to an iron pin set (having passed through an iron pin set at 30.00 feet), Thence with the lands of now or formerly Ellis Morrow as found in Volume 824 Page 208 of the deed records of Muskingum County, Ohio S 87° 11' 14" E a distance of 59.00 feet to the beginning and containing 0.275 acres more or less and being all the property conveyed in Volume 685 Page 334 of the deed records of Muskingum County, Ohio. *AUT PARCEL # 1-23-00032*

Iron pins set are 5/8 inch rebar 30 inches long, capped SPILKER LS-5862.

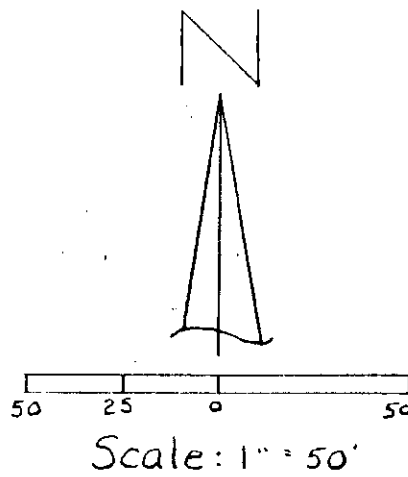
Bearings are magnetic and are for angle purposes only.

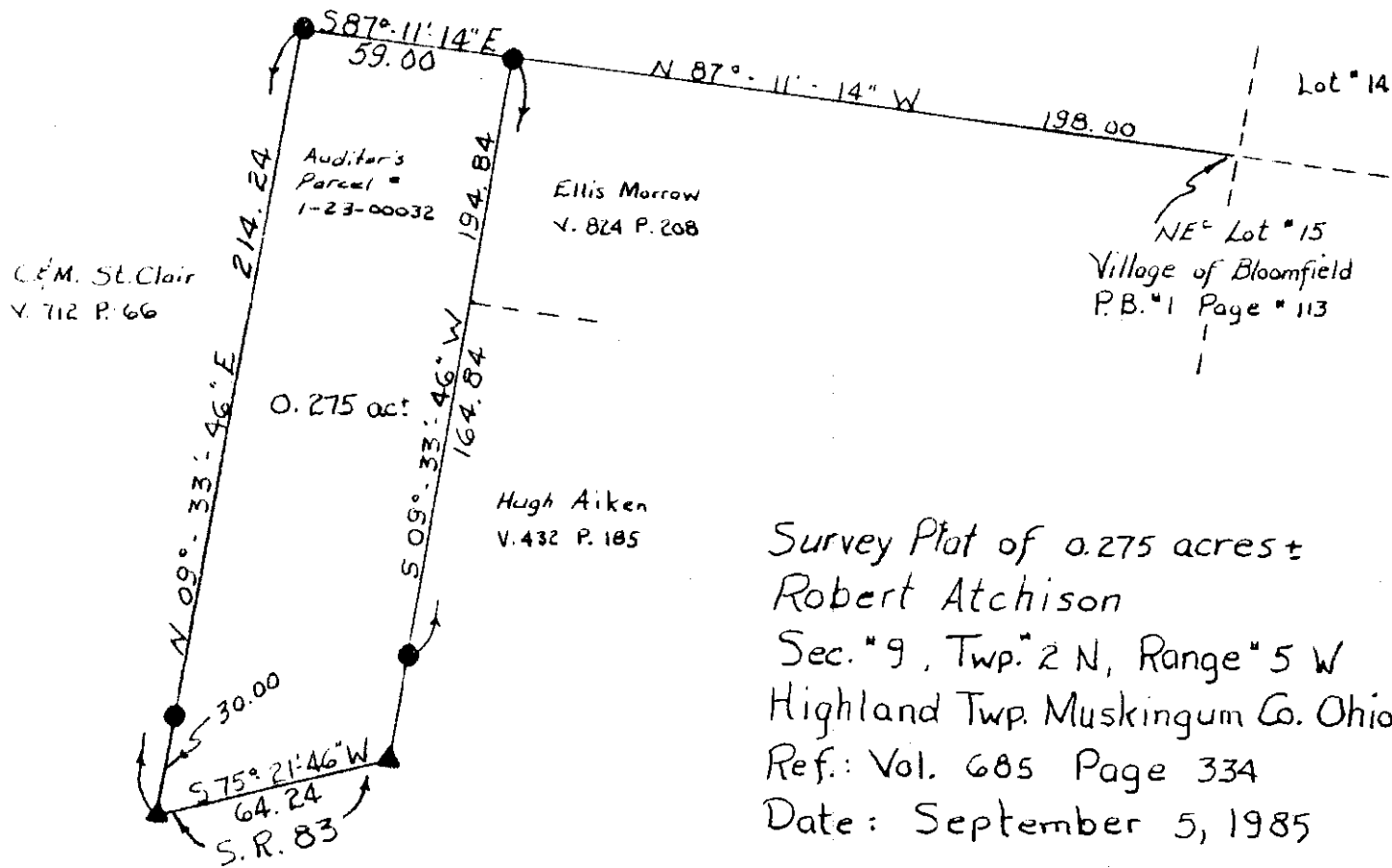
