Ruby, Volume 506, Page 261, for 330.02 ft. to a rail-road spike set in the center of said TR 185, thence S 86° 27' 05" E for 3.77 ft. to a rail-road spike set in TR 185, in the East line of the said Northwest quarter of Section 11, witness by an iron pin found #5 rebar capped Claus L.S. 6456, in the East line of the Southwest quarter of Section 10, 11.92 ft. North of the Southeast corner of the said Southwest quarter of Section 10, bearing N 3° 28' 19" E for 1344.74 ft., thence S 3° 28' 19" W along the said East line of the said Northwest guarter of Section 11, for 559.28 ft. to a rail-road spike set near the center of TR 185; thence N 86° 49' 52" W for 16.18 ft. to an

iron pin found #5 rebar capped Walton L.S. 7675; thence continuing N 86° 49' 52" W for 259.72 ft. to an iron pin found #5 rebar capped Walton L.S. 7675; thence S 3° 50' 55" W for 773.26 ft. to the place of beginning, containing 19.645 acres.

The bearings are based on the West line of a 5.00 acres parcel survey 11-5-98 by Steven B. Walton L.S. 7675 for the Grantor, and are for the purpose of calculating angles only, the iron pin set are that of a #5 rebar with a plastic I.D. cap Neuhart L.S. 5692.
