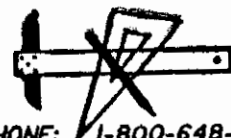

STRAUSS, ETAL, AS RECORDED IN DEED VOLUME 380, PAGE 952, IN THE GUERNSEY COUNTY DEED RECORDS, BEING THE NORTHEAST CORNER OF THE TRACT HEREIN DESCRIBED, AND PASSING OVER AN IRON PIN SET AT 25.00 FEET;

THENCE, S 02°38'43" W 683.27 FEET WITH THE EAST LINE OF SAID PARCEL CONVEYED TO STRAUSS ETAL OF WHICH THIS DESCRIPTION IS A PART, THE SAME BEING SAID COUNTY LINE AND THE EAST LINE OF SECTION 11, TO AN IRON PIN SET MARKING THE SOUTHEAST CORNER OF SAID QUARTER SECTION, BEING THE SOUTHEAST CORNER OF SAID PARCEL CONVEYED TO STRAUSS ETAL OF WHICH THIS DESCRIPTION IS A PART, BEING THE NORTHEAST CORNER OF SAID PARCEL CONVEYED TO TAYLOR, AND BEING THE SOUTHEAST CORNER OF THE TRACT HEREIN DESCRIBED;

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF HIGHLAND, AND BEING IN THE NORTHEAST QUARTER OF SECTION 11, TOWNSHIP 2N, RANGE 5W, IN THE UNITED STATES MILITARY LANDS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

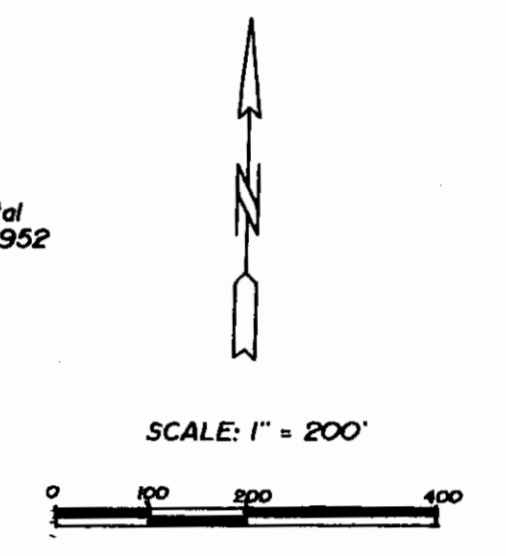
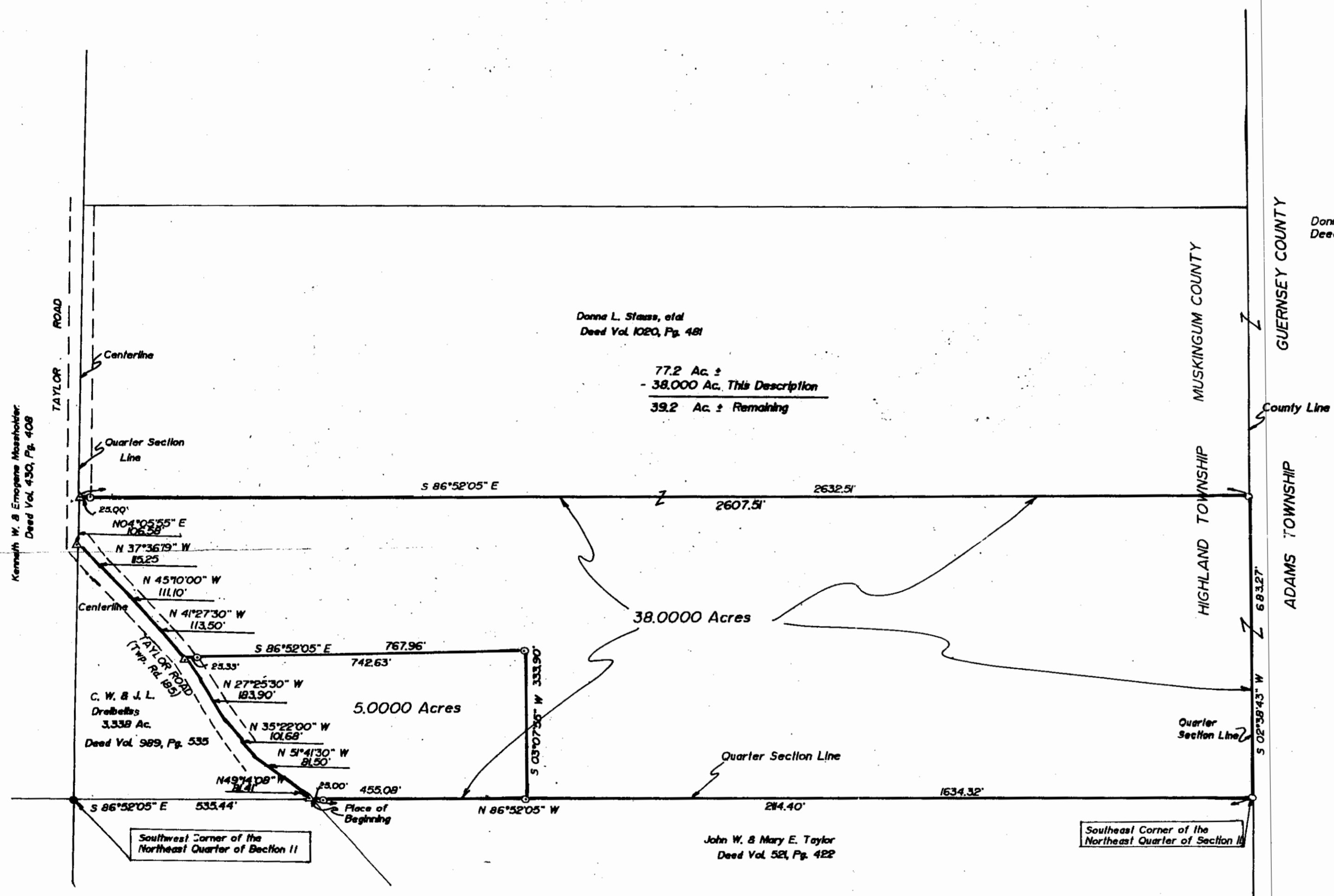
BEING A SURVEY OF A PART OF PARCEL CONVEYED DONNA L. STRAUSS, ETAL, AS RECORDED IN DEED VOLUME 1020, PAGE 481, IN THE MUSKINGUM COUNTY DEED RECORDS, AND FURTHER DESCRIBED AS FOLLOWS;

COMMENCING AT AN IRON PIN FOUND MARKING THE SOUTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 11, AND BEING THE SOUTHWEST CORNER OF A 3.338 ACRE PARCEL CONVEYED TO CHARLIE W. AND JEANETTE L. DREIBELISS, AS RECORDED IN DEED VOLUME 989, PAGE 535;

THENCE, S 86°52'05" E 535.44 FEET WITH THE SOUTH LINE OF SAID QUARTER SECTION, THE SAME BEING THE SOUTH LINE OF SAID 3.338 ACRE PARCEL CONVEYED TO DREIBELISS, TO A RAILROAD SPIKE SET IN THE CENTERLINE OF TAYLOR ROAD (TOWNSHIP ROAD NO. 185) MARKING THE SOUTHEAST CORNER OF SAID 3.338 ACRE PARCEL, BEING THE SOUTHWEST CORNER OF SAID PARCEL CONVEYED TO STRAUSS ETAL, BEING THE NORTHWEST CORNER OF A PARCEL CONVEYED TO JOHN W.
