**THENCE WITH THE WEST LINE OF SECTION 11, NORTH 01 DEGREES 56 MINUTES 38 SECONDS EAST 1343.50 FEET TO AN IRON PIN SET AT THE SOUTHWEST CORNER OF THE ABOVE SAID McQUAIN PARCEL (SOUTH EAST CORNER OF A PARCEL CONVEYED TO BRIAN STACY BABCOCK AND STEPHANIE E. BALL (NOW KNOWN AS STEPHANIE E. BABCOCK) IN DEED VOLUME 1157, PAGE 68), SAID IRON PIN BEING SOUTH 87 DEGREES 14 MINUTES 47 SECONDS EAST 5.81 FEET FROM AN EXISTING IRON PIN (1 INCH REBAR);**

**THENCE CONTINUING WITH THE SAID SECTION LINE AND WITH THE WEST LINE OF THE SAID McQUAIN PARCEL (EAST LINE OF THE SAID BABCOCK AND BALL PARCEL), NORTH 01 DEGREES 56 MINUTES 38 SECONDS EAST 462.64 FEET TO AN IRON PIN SET, SAID IRON PIN SET BEING THE **PLACE OF BEGINNING** FOR THE EASEMENT HEREIN INTENDED TO BE DESCRIBED;**

VOLUME 2457, PAGE 645, NORTH 01 DEGREES 56 MINUTES 38 SECONDS EAST 53.60 FEET TO A POINT, SAID POINT BEING SOUTH 01 DEGREES 56 MINUTES 38 SECONDS WEST 797.72 FEET FROM AN EXISTING IRON PIN (1 INCH REBAR);**

**THENCE LEAVING THE SAID SECTION LINE AND TRAVERSING THROUGH THE ABOVE SAID McQUAIN PARCEL THE FOLLOWING FOUR COURSES AND DISTANCES:**

1. NORTH 70 DEGREES 49 MINUTES 24 SECONDS EAST 53.60 FEET TO A POINT, SAID POINT BEING SOUTH 01 DEGREES 56 MINUTES 38 SECONDS WEST 217.97 FEET FROM AN IRON PIN SET;
2. SOUTH 01 DEGREES 56 MINUTES 38 SECONDS WEST 36.46 FEET TO A POINT, PASSING AN IRON PIN SET AT 13.33 FEET;
3. WITH A CURVE TO THE RIGHT HAVING A RADIUS OF 25.00 FEET (CHORD BEARING OF SOUTH 36 DEGREES 23 MINUTES 01 SECONDS WEST 28.28 FEET AND A DELTA ANGEL OF 68 DEGREES 52 MINUTES 46 SECONDS) AN ARC DISTANCE OF 30.05 FEET TO A POINT;
4. SOUTH 70 DEGREES 49 MINUTES 24 SECONDS WEST 36.46 FEET TO THE **PLACE OF BEGINNING**;
