

Survey of the Bloomfield Presbyterian Church

Being a part of land located in the State of Ohio, Muskingum County, Highland Township, part of the southwest quarter of Section 10, Township 2 North, Range 5 West, United States Military District.

Being part of the lands conveyed to The Bloomfield Presbyterian Church, in Deed Record 138, page 515, bounded and described as follows:

Beginning at a concrete monument found at the southwest corner of Section 10, Township 2 North, Range 5 West;

thence along the west line of Section 10 North 02 degrees 27 minutes 15 seconds East 115.00 feet to an iron pin found;

thence continuing along the west line of Section 10 North 02 degrees 27 minutes 15 seconds East 27.42 feet to a point in the centerline of State Route 209;

thence along the centerline of State Route 209 the following four courses:

1. South 71 degrees 04 minutes 59 seconds East 49.32 feet to a point;
2. South 71 degrees 37 minutes 34 seconds East 159.93 feet to a point;
3. South 70 degrees 55 minutes 49 seconds East 25.28 feet to a point;
4. On a curve to the left having a radius of 1834.01 feet, a delta angle of 00 degrees 22 minutes 30 seconds, a chord bearing and distance of South 71 degrees 59 minutes 27 seconds East 12.00 feet to a point;

thence leaving the centerline of State Route 209 South 18 degrees 07 minutes 08 seconds West 76.09 feet to an iron pin set on the south line of Section 10;

thence along the south line of Section 10 North 87 degrees 46 minutes 26 seconds West 68.56 feet to an iron pin found;

thence leaving the south line of Section 10 North 12 degrees 30 minutes 00 seconds West 80.62 feet to an iron pin found;

thence North 73 degrees 30 minutes 00 seconds West 94.90 feet to an iron pin found;

thence South 13 degrees 00 minutes 00 seconds West 103.19 feet to an iron pin found on the south line of Section 10;

thence along the south line of Section 10 North 87 degrees 46 minutes 26 seconds West 16.03 feet to the place of beginning containing 0.34 acres, more or less,

Part of Parcel No.: 23-60-11-24-000 (\pm 0.34 acres)

Iron pins set are 5/8 inch rebar 30 inches long with identification caps ("MUSK CTY" "SWIERZ 8062"). This legal description was written by Denis P. Swierz based on a field survey completed March 2016 by Muskingum County Engineers' Office. The bearings in this description are based on NAD 83, Ohio South Zone, State Plane coordinates as per GPS Observations from Muskingum County Engineer GPS monument - **GPS 81**.

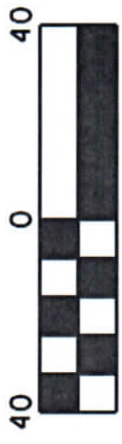

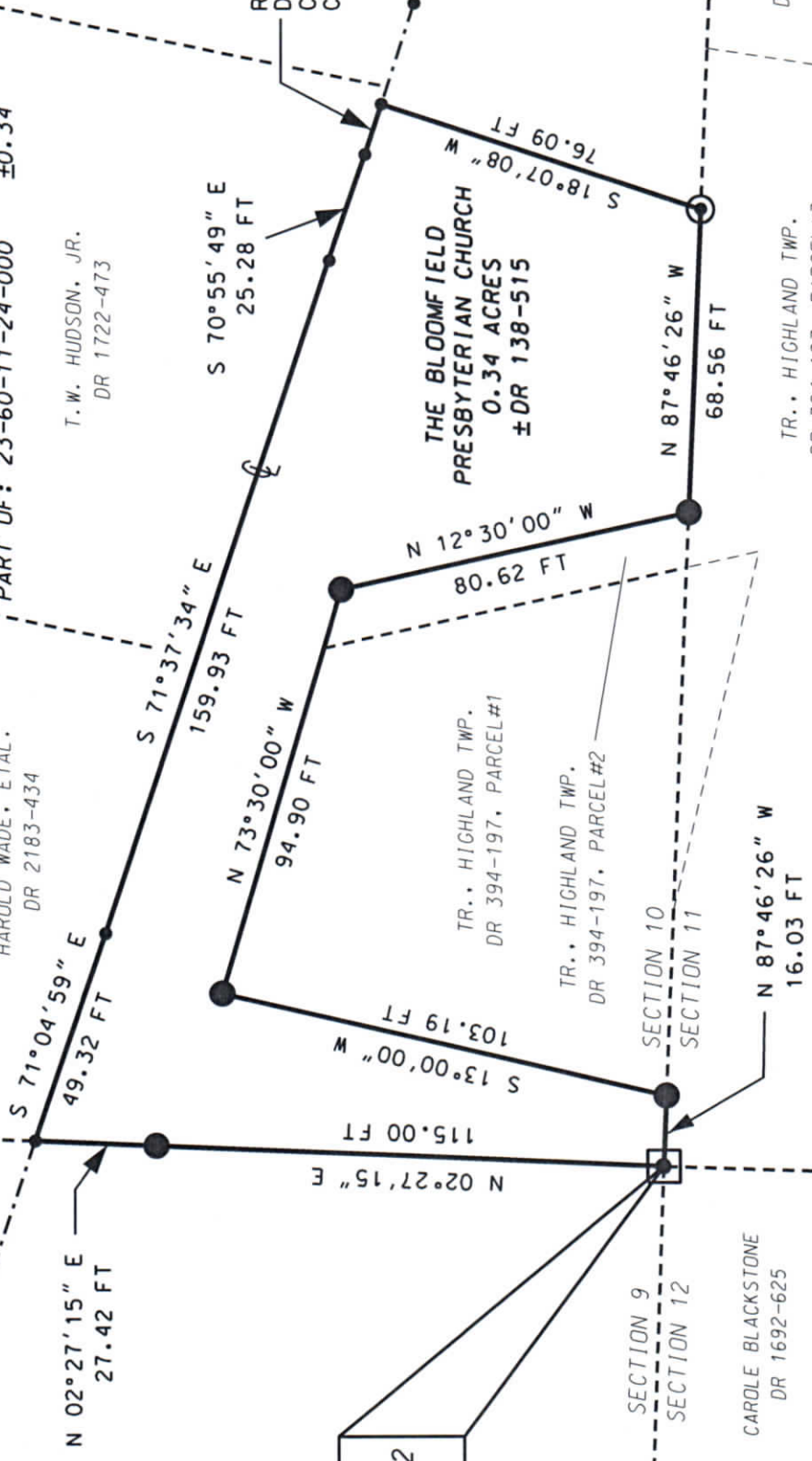
