Commencing at a stone (found) marked at the common corner for the Northwest and Southwest Quarters of said Section 12 and for the Northeast and Southeast Quarters of Section 13 of said Township and Range;

- TIE- **THENCE South 87 degrees 31 minutes 19 seconds East 649.40 feet** along the common line for said Northwest and Southwest Quarters of Section 12 to an iron pin (set) at the place of beginning for the property herein intended to be described;
- #1- **THENCE North 02 degrees 28 minutes 41 seconds East 376.62 feet** into said Northwest Quarter and through said Kuhn property to an iron pin (set);
- #2- **THENCE South 89 degrees 53 minutes 46 seconds East 713.87 feet** continuing through said Kuhn property to an iron pin (set);

DESCRIPTION OF SURVEY FOR JAMES P KUHN JOB#2045-LOT 1 EASEMENT

Situated in the State of Ohio, County of Muskingum, Township of Highland:

Being within the Northwest Quarter, Section 12, Township 2, Range 5, of the US Military District, further **being an easement** crossing a portion of the James P Kuhn property recorded in Official Record Volume 2364, Page 355 of said county's deed records, and more particularly described as follows;

Commencing at an iron pin (found) at the center of Section 12;

- TIE-1 THENCE North 02 degrees 12 minutes 56 seconds East 860.96 feet** along the common line for said Northwest and Northeast Quarters of Section 12 to an iron pin (found) at Southeast corner of the Hallie E Baker property recorded in Official Record Volume 2244, Page 460;
- TIE-2 THENCE North 87 degrees 38 minutes 55 seconds West 157.04 feet** into said Northwest Quarter and along said Baker property to an unmarked point in the centerline of State Route 83 (Friendship Drive), passing an iron pin (found) at 126.30 feet;

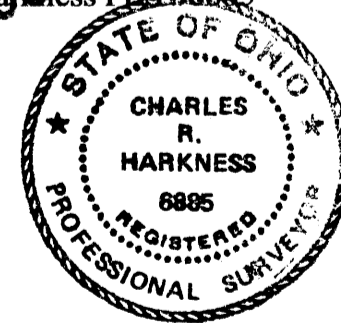

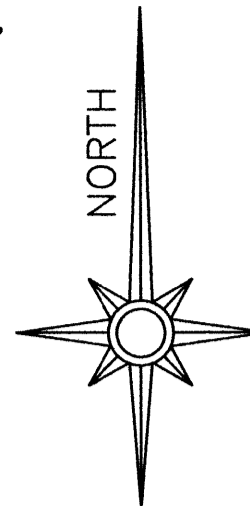
