**LEGAL DESCRIPTION FOR

TRACT 1

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF HIGHLAND, AND BEING PART OF THE SOUTHWEST QUARTER OF SECTION 23, TOWNSHIP 2, RANGE 5, AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 1109, PAGE 147 OF THE MUSKINGUM COUNTY DEED RECORDS; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 23, THENCE, NORTH 01 DEGREES - 59 MINUTES - 36 SECONDS WEST, 874.42 FEET TO A POINT AT THE INTERSECTION OF THE EAST LINE OF SAID SOUTHWEST QUARTER, AND THE CENTERLINE OF TOWNSHIP ROAD #187; THENCE, CONTINUING NORTH 01 DEGREES - 59 MINUTES - 36 SECONDS WEST, 501.35 FEET TO AN IRON PIN FOUND; THENCE, NORTH 74 DEGREES - 40 MINUTES - 32 SECONDS WEST, 393.90 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 13 DEGREES - 21 MINUTES - 36 SECONDS WEST, 386.18 FEET TO A POINT IN THE CENTERLINE OF SAID TOWNSHIP ROAD #18; THENCE, ALONG THE CENTERLINE THEREOF, NORTH 46 DEGREES - 17 MINUTES - 14 SECONDS WEST, 181.79 FEET TO A POINT; THENCE, NORTH 45 DEGREES - 23 MINUTES - 15 SECONDS WEST, 115.70 FEET TO A POINT; THENCE, NORTH 44 DEGREES - 26 MINUTES - 30 SECONDS EAST, 278.06 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 18.67 FEET; THENCE, SOUTH 74 DEGREES - 40 MINUTES - 32 SECONDS EAST, 112.30 FEET TO THE POINT OF BEGINNING, AND CONTAINING 1.451 ACRES MORE OR LESS.

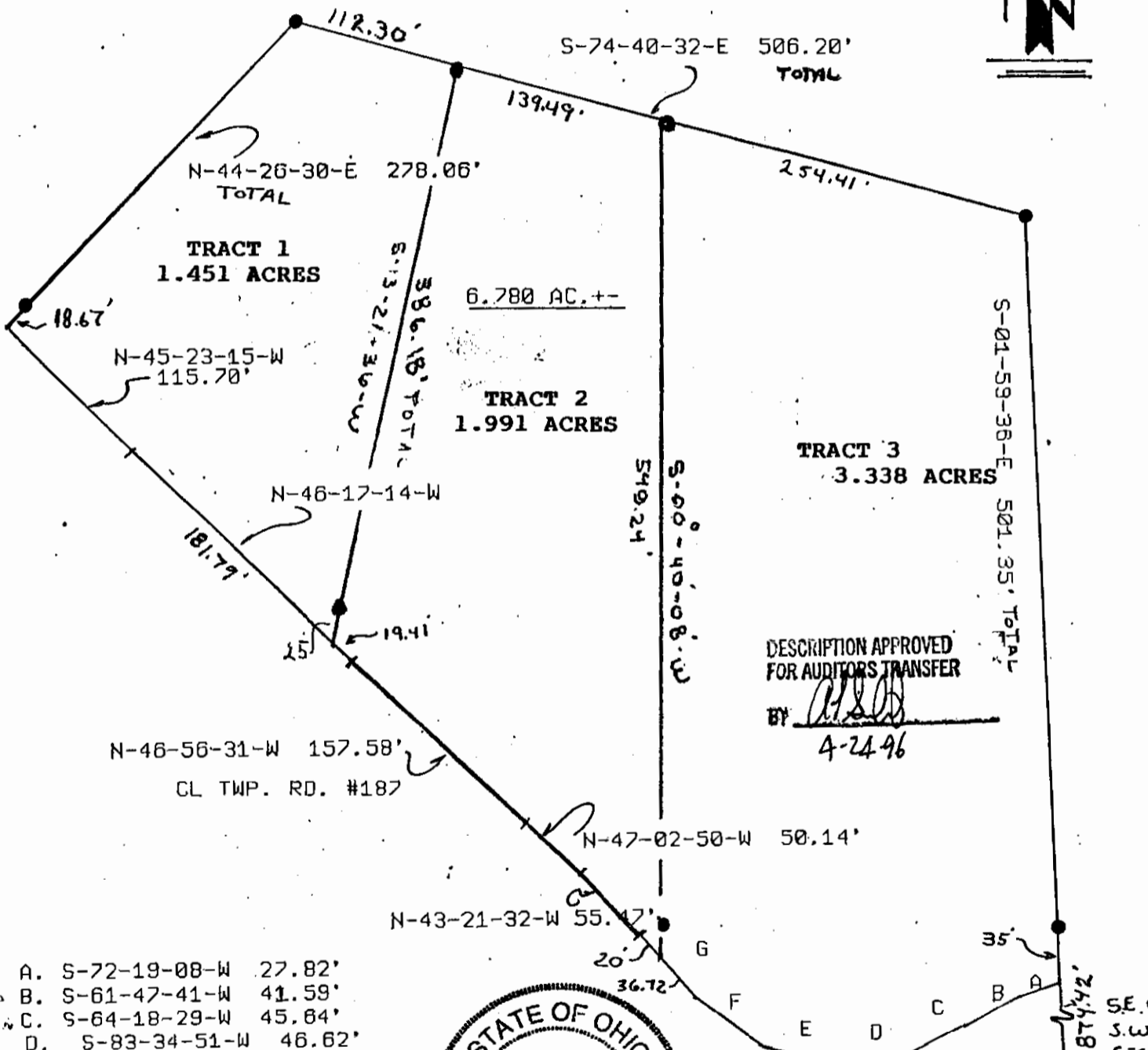
