Ross, Trustees, (OR 3120-580), South 87 degrees 59 minutes 08 seconds East, 393.76 feet to an iron pin found, on the northwest corner of lands presently owned by Clarence S. and Patricia D. Hickenbottom, (OR 2876-386);

Thence along the lines of said Hickenbottom lands the following two courses:

- 1.) South 02 degrees 00 minutes 07 seconds West, 174.41 feet to an iron pin found;
- 2.) South 87 degrees 44 minutes 39 seconds East, 271.31 feet to a point in the centerline of Friendship Drive, (St. Rte. 83, R\W 60'), passing an iron pin found at 240.49 feet;

Thence along the centerline of said drive the following three courses:

- 1.) Along a non-tangent curve to the left with a delta angle of 12 degrees 08 minutes 59 seconds, a radius of 968.40, and arc length of 205.35 feet, and a chord which bears South 17 degrees 37 minutes 30 seconds East, 204.97 feet to a point;

- 3.) South 82 degrees 22 minutes 03 seconds East, 40.23 feet to an iron pin found on the southwest corner of lands presently owned by Michael J. Yarger, (OR 1158-243);

- 3.) South 06 degrees 27 minutes 50 seconds West, 442.71 feet to a point, on the quarter section
