Commencing at the unmarked Northwest corner of the Southwest Quarter of Section #3, being in the road bed of Hunt Road (Township Road #294), also being a corner of Heather Hill Subdivision as recorded in Plat Book 14, Page 99; thence S 86 46 00 E 225.54 feet along the North line of the Southwest Quarter, to the unmarked Northeast corner of Lot #16 of said Heather Hill Subdivision, passing an iron pin (found) at 25.57 feet; thence S 03 57 00 W 600.54 feet along the East line of said Heather Hill Subdivision, as monumented by a unrecorded resurvey of Heather Hill Subdivision completed by W. J. Biedenbach PLS #5718 in December 1981, to an iron pipe (found) at the common Eastern corner for Lots #21 & #22 of said subdivision, passing an iron pipe (found) at 0.43 feet; thence S 16 04 10 E 121.30 feet along the a line of said resurvey of Heather Hill Subdivision to an iron pipe (found) at the common Eastern corner of Lot #22 & #23 of said subdivision, and the place of beginning for the property herein intended to be described;

- #1- thence N 74 32 00 E 260.00 feet through said Lewis to an iron pin (set);
- #2- thence S 04 26 10 E 411.34 feet continuing through said Lewis property to an iron pin (set);
- #3- thence S 74 28 30 W 180.00 feet continuing through said Lewis property to an iron pipe (found) at the Northeast corner of Lot #24 of said subdivision as monumented by said resurvey;
- #4- thence S 74 28 30 W 225.00 feet along a line of said resurvey of Heather Hill Subdivision to the center of Pert Hill Road Township Road #413, passing an iron pin (set) at the Northwest corner of said Lot #24 at 200.00 feet;
- #5- thence N 15 26 50 W 274.16 feet along the center of said road to the unmarked extension of the South line of said Lot #23 of said subdivision as monumented by said resurvey;
- #6- thence N 74 32 10 E 225.00 feet along a line of said resurvey of Heather Hill Subdivision to an iron pipe (found) at the Southeast corner of said Lot #23, passing an iron pipe (found) at the Southwest corner of said Lot #23 at 25.00 feet:
- #7- thence N 16 04 50 W 130.02 feet along a line of said resurvey of Heather Hill Subdivision to the place of beginning containing 3.45 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
